### A BILL FOR AN ACT

RELATING TO THE ECONOMY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that having a 2020 Hawaii
- 2 Philippines sister city trade show and economic outlook
- 3 symposium ("symposium") would expand the economic partnership
- 4 between the State and the Philippines sister states and cities.
- 5 The State's communities, individuals, and businesses would have
- 6 the opportunity to meet business owners and city officials from
- 7 the Philippines to gain a new perspective on Filipino culture
- 8 and business and trade practices, as well as allow participants
- 9 to develop relationships and business opportunities which may
- 10 lead to increased trade and cultural diversity. In addition to
- 11 meetings and presentations, the symposium would cover the
- 12 State's economic objectives, including but not limited to the
- 13 local economy, energy, agriculture, and environmental
- 14 sustainability.
- 15 The legislature further finds that the symposium
- 16 participants from the Philippines would have the opportunity to
- 17 showcase their products, craftsmanship, and artisan designs, and

- 1 provide regional perspectives on industry best practices. In
- 2 turn, the State's Filipino business community, which consists of
- 3 three hundred Filipino-American organizations, would have the
- 4 opportunity to meet and build business relationships, with the
- 5 Philippines sister city symposium participants, thus creating
- 6 partnerships for future trade opportunities.
- 7 The legislature also finds that the State and League of
- 8 Provinces of the Philippines, should they co-host the symposium,
- 9 will strengthen their relationship and meet the requirements of
- 10 their Memorandum of Understanding dated July 2, 2017.
- 11 The symposium would also create an economic benefit for the
- 12 State from the likely increase in tax revenue generated by the
- 13 influx of travelers. In addition, foreign investment in
- 14 companies in the State or the Philippines sister cities could
- 15 create other long term benefits.
- In addition, if the symposium is held, the Filipino Chamber
- 17 of Commerce of Hawaii would fulfill its mission of providing its
- 18 members with resources to broaden their economic opportunities
- 19 with the Philippines sister cities. The Filipino Chamber of
- 20 Commerce of Hawaii would serve as a facilitator of economic
- 21 activity for the State with the Philippines.



- 1 Accordingly, the purpose of this Act is to appropriate
- 2 funds to plan and hold the symposium.
- 3 SECTION 2. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$50,000 or so much
- 5 thereof as may be necessary for fiscal year 2019-2020 for the
- 6 Filipino Chamber of Commerce of Hawaii to plan for a 2020 Hawaii
- 7 Philippines sister city trade show and economic outlook
- 8 symposium.
- 9 The sum appropriated shall be expended by the department of
- 10 business, economic development, and tourism for the purposes of
- 11 this Act.
- 12 SECTION 3. This Act shall take effect on July 1, 2019.
