BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1		SEC	CTION	1.	Unless	otherwise	clear	from	the	context,	as
2	used	in	this	Act	:						

3 "Expending agency" means the executive department, 4 independent commission, bureau, office, board, or other establishment of the state government (other than the 5 legislature, Office of Hawaiian Affairs, and judiciary), the 6 political subdivisions of the State, or any quasi-public 7 8 institution supported in whole or in part by state funds, which is authorized to expend specified appropriations made by this 9 10 Act.

Abbreviations, where used to denote the expending agency,shall mean the following:

14 "Means of financing" or "MOF" means the source from which 15 funds are appropriated or authorized to be expended for the 16 programs and projects specified in this Act. All appropriations

1 "Position ceiling" means the maximum number of permanent 2 and temporary full-time equivalent positions authorized for a 3 particular program during a specified period or periods, as denoted by an asterisk for permanent full-time equivalent 4 5 positions and a pound sign for temporary full-time equivalent 6 positions. "Program ID" means the unique identifier for the specific 7 program and consists of the abbreviation for the organization 8 9 responsible for carrying out the program followed by the 10 organization number for the program. SECTION 2. The following sums, or so much thereof as may 11 be sufficient to accomplish the purposes and programs designated 12 13 herein, are hereby appropriated or authorized, as the case may be, from the means of financing specified to the expending 14 agencies designated for the fiscal biennium beginning July 1, 15 2019, and ending June 30, 2021. The total expenditures and the 16 number of positions in each fiscal year of the biennium shall 17 18 not exceed the sums and the position ceilings indicated for each fiscal year, except as provided elsewhere in this Act or as 19 20 provided by general law.
