A BILL FOR AN ACT

RELATING TO GOVERNMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is a need to
- 2 modernize state government to reflect the current generation of
- 3 Hawaii residents, as recent studies have shown a lack of public
- 4 support for government in the State. Furthermore, the current
- 5 structure of government presents challenges to effective and
- 6 efficient governing at all levels. The legislature also finds
- 7 that the needs of society have changed drastically, with greater
- 8 emphasis on modernization, transparency, and accountability, and
- 9 these needs should be reflected in the functions and services
- 10 provided by state government.
- 11 The purpose of this Act is to establish the state
- 12 government realignment commission to periodically review the
- 13 state executive branch's departments, divisions, and agencies,
- 14 including functions and services, and submit its findings and
- 15 recommendations to the legislature.

- 1 SECTION 2. The Hawaii Revised Statutes is amended by
- 2 adding a new chapter to title 4 to be appropriately designated
- 3 and to read as follows:
- 4 "CHAPTER
- 5 STATE GOVERNMENT REALIGNMENT COMMISSION
- 6 § -1 Establishment of the commission. (a) There shall
- 7 be a state government realignment commission, hereinafter called
- 8 the commission, which shall be placed within the department of
- 9 accounting and general services for administrative purposes.
- 10 The commission shall consist of seven members. Three members
- 11 shall be appointed by the governor, two members by the president
- 12 of the senate, and two members by the speaker of the house of
- 13 representatives. All members shall be subject to the advice and
- 14 consent of the senate. The commission shall elect its
- 15 chairperson from one of its members.
- 16 (b) The members of the commission shall receive no
- 17 compensation for their services, but shall be reimbursed for
- 18 actual expenses incurred in the performance of their duties.
- 19 (c) The commission may enter into contracts with
- 20 consultants and engage employees necessary to perform its duties
- 21 without regard to chapter 76. Departments of the state

- 1 government shall make available to the commission the data and
- 2 facilities as are necessary for the commission to perform its
- 3 duties.
- 4 § -2 Term. A commission shall be appointed and
- 5 confirmed on or before July 1, 2021, and a new commission shall
- 6 be appointed and confirmed on or before July 1 every ten years
- 7 thereafter; provided that if any vacancy occurs in the
- 8 membership of a commission prior to the completion of its duties
- 9 or dissolution, there shall be appointed a replacement member in
- 10 accordance with sections -1 and 26-34. The commission shall
- 11 meet from time to time as necessary to execute its duties. The
- 12 commission shall dissolve upon the adjournment sine die of the
- 13 legislature to which it submits the evaluation and
- 14 recommendations required by section -3.
- 15 § -3 Duties. The commission shall conduct a systematic
- 16 review of the state executive branch's departments, divisions,
- 17 and agencies, including functions and services, using standards
- 18 such as equity, efficiency, and modernization to consolidate,
- 19 expand, or reassign services. Thirty days prior to the
- 20 convening of the third regular session of the legislature after
- 21 the members of the commission have been appointed, the

- 1 commission shall submit to the legislature the findings of its
- 2 systemic review of the state executive branch and any
- 3 recommendations based on the findings; provided that the
- legislature shall review and take into consideration the 4
- 5 commission's findings and recommendations."
- 6 SECTION 3. This Act shall take effect upon its approval.
