A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that a gap exists between
- 2 the skills that students in the State have upon graduation from
- 3 high school and the skills that employers in the State are
- 4 seeking. Business leaders in Hawaii's expanding industries
- 5 report that it is often difficult to recruit local applicants
- 6 who have necessary skills and experiences.
- 7 The legislature further finds that educational programs
- 8 specializing in career readiness and technical skills can be
- 9 effective in preparing students in Hawaii to enter the State's
- 10 job market. Educational initiatives at schools within the State
- 11 have been established to develop students' technical skills and
- 12 prepare them to enter the workforce.
- 13 The purpose of this Act is to establish a statewide policy
- 14 that supports those students who want to receive career and
- technical skills education. To effectuate this statewide 15
- policy, this Act supports the expansion of the numbers of 16
- 17 students receiving career and technical skills education by

4	SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
5	amended by adding a new section to part IV, subpart C to be
6	appropriately designated and to read as follows:
7	"§302A- Career and technical education programs;
8	enrollment. (a) Any school having a career and technical
9	education program shall enroll all students:
10	(1) Who reside within the school's service area pursuant
11	to section 302A-1143 and submit a timely application
12	for participation in the program;
13	(2) Enrolled in the school during the previous school yea
14	and who submit a timely application for participation
15	in the program; and
16	(3) Who reside outside the school's service area and who
17	submit a timely application;
18	provided that if enrolling all students pursuant to paragraphs
19	(1), (2), and (3) will cause the enrollment of the school to
20	exceed the capacity of a program, class, grade level, or

building, the school shall enroll all students described in

- 1 paragraphs (1) and (2) and fill the remaining capacity, if any,
- 2 of the program, class, grade level, or building by selecting
- 3 eligible students described in paragraph (3) through a lottery
- 4 system.
- 5 (b) The department shall adopt rules pursuant to chapter
- 6 91 to effectuate the purposes of this section.
- 7 (c) For the purpose of this section, "career and technical
- 8 education program" means a program operated by a school that
- 9 primarily focuses on learning and skill development in students
- 10 through the practical application of academic and technical
- 11 skills and knowledge."
- 12 SECTION 3. Section 302A-1143, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- 14 "\$302A-1143 Attending school in what service area. A
- 15 person of school age shall be required to attend the school of
- 16 the service area, as determined by the department, in which the
- 17 person resides, unless:
- 18 (1) The person is enrolled in a Hawaiian language medium
- education program or charter school;
