A BILL FOR AN ACT

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to propose an 2 amendment to the Constitution of the State of Hawaii to authorize the state legislature to establish a surcharge on real 3 4 property near rapid transit stations for the purpose of funding 5 infrastructure improvements near those rapid transit stations. 6 SECTION 2. Article VIII, section 3, of the Constitution of 7 the State of Hawaii is amended to read as follows: 8 "TAXATION AND FINANCE 9 Section 3. The taxing power shall be reserved to the 10 State, except so much thereof as may be delegated by the 11 legislature to the political subdivisions, and except that all 12 functions, powers and duties relating to the taxation of real 13 property shall be exercised exclusively by the counties, with 14 the exception of the county of Kalawao[-]; provided that the 15 legislature may establish, as provided by law, a surcharge on

1	real property taxes for real property parcels located within one
2	mile at their nearest point of any rapid transit station to fund
3	infrastructure improvements needed to support or accommodate the

7	be established solely to fund improvements in the area of the
8	transit station which makes the parcel eligible for the
