BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- (c) The Hawaii tree planting program shall be directed and managed by a program administrator to be appointed by the chairperson of the board of land and natural resources. The program administrator position shall not be subject to chapters 76 and 89, Hawaii Revised Statutes. The Hawaii tree planting program administrator shall:
- (1) Research and apply for appropriate and availablefederal funding, including grant moneys;
