A BILL FOR AN ACT

RELATING TO THE CHAIRPERSON OF THE HAWAIIAN HOMES COMMISSION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the state water code
- 2 has not been implemented to fully comply with the requirements
- 3 of section 174C-101(a), Hawaii Revised Statutes, that adequate
- 4 reserves of water for current and foreseeable development of
- 5 Hawaiian home lands be incorporated into and protected by the
- 6 decisions of the commission on water resource management. The
- 7 commission on water resource management has only reserved water
- 8 for current and foreseeable development of Hawaiian home lands
- 9 on Oahu and Molokai, and in Keauhou on the island of Hawaii.
- 10 The legislature further finds that representation on the
- 11 commission on water resource management by the Hawaiian homes
- 12 commission and the department of Hawaiian home lands is
- 13 necessary for section 174C-101(a), Hawaii Revised Statutes, to
- 14 be properly fulfilled.
- The purpose of this Act is to add the chairperson of the
- 16 Hawaiian homes commission or the chairperson's designee and the
- 17 chairperson of the department of Hawaiian home lands or the

- 1 chairperson's designee as ex officio, voting members of the
- 2 commission on water resource management.
- 3 SECTION 2. Section 174C-7, Hawaii Revised Statutes, is
- 4 amended by amending subsection (a) and (b) to read as follows:
- 5 "(a) There is established within the department a
- 6 commission on water resource management consisting of [seven]
- 7 nine members which shall have exclusive jurisdiction and final
- 8 authority in all matters relating to implementation and
- 9 administration of the state water code, except as otherwise
- 10 specifically provided in this chapter.
- 11 (b) Five members shall be appointed by the governor
- 12 subject to confirmation by the senate in the manner prescribed
- 13 in subsection (d). Each [member] of the five appointed members
- 14 shall have substantial experience in the area of water resource
- 15 management; provided that at least one member shall have
- 16 substantial experience or expertise in traditional Hawaiian
- 17 water resource management techniques and in traditional Hawaiian
- 18 riparian usage such as those preserved by section 174C-101. The
- 19 chairperson of the board of land and natural resources shall be
- 20 the chairperson of the commission. The director of health or
- 21 the director's designee shall serve as an ex officio[+], [+]

- 1 voting member. The chairperson of the Hawaiian homes commission
- 2 or the chairperson's designee shall serve as an ex officio,
- 3 voting member. The chairperson of the department of Hawaiian
- 4 home lands or the chairperson's designee shall serve as an ex
- 5 officio voting member."
- 6 SECTION 3. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 4. This Act shall take effect on July 1, 2020.
