### A BILL FOR AN ACT

RELATING TO FIRE PROTECTION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the state fire
- 2 council has a wide range of responsibilities, from reviewing and
- 3 maintaining the state fire code to coordinating the collection
- 4 of fire data to supporting contingency planning for
- 5 firefighters. The state fire council is responsible for
- 6 establishing statewide qualifications for testing, certifying
- 7 and credentialing the individuals who maintain and test portable
- 8 fire extinguishers, fire protection systems, and fire alarms.
- 9 The council advises the governor and the legislature and
- 10 conducts public outreach and education campaigns on matters
- 11 relating to fire prevention, protection, and safety. The
- 12 council also oversees the reduced ignition propensity cigarette
- 13 program and administers the reduced ignition propensity
- 14 cigarette program special fund.
- 15 The legislature recognizes that, until 2001, the state fire
- 16 council received no funding for staff personnel to fulfill its
- 17 extensive responsibilities. Instead, county employees were

- 1 required to perform these duties without any additional pay. In
- 2 2001, the governor directed the department of labor and
- 3 industrial relations to allocate \$35,000 to fund one part-time
- 4 employee for the state fire council. In 2011, the legislature
- 5 appropriated an additional \$71,000 for two paid positions.
- 6 The legislature finds that additional paid personnel would
- 7 allow the state fire council to expand programs that benefit
- 8 vulnerable and at-risk individuals. Statewide education and
- 9 outreach programs could promote the protection of life,
- 10 property, and the environment. The state fire council could
- 11 expand existing programs that have proven very successful,
- 12 including its firefighter safety guide program for the State's
- 13 youth and the residential smoke alarm installation program for
- 14 at-risk seniors.
- 15 Accordingly, the purpose of this Act is to authorize the
- 16 state fire council to administer and expend funds from the
- 17 reduced ignition propensity cigarette program special fund to
- 18 support statewide fire prevention and safety programs.
- 19 SECTION 2. Section 132C-9, Hawaii Revised Statutes, is
- 20 amended to read as follows:

12	requirements of section 132C-4, including employing one full-					
13	time administrator and one full-time assistant whose duties					
14	include:					
15	(1)	Adopting administrative rules for program				
16		implementation, establishing compliance inspections,				
17		and approving forms and enforcement procedures and				
18		guidelines;				
19	(2)	Receiving certifications for approximately six hundred				
20		different brands and styles of cigarettes from the				
21		manufacturers:

1	(3)	compiling a list of the digarette brands and styles		
2		for which manufacturers have submitted certifications		
3		verifying tax stamp compliance with the department of		
4		the attorney general, and posting the list of		
5		certified brands and styles on a state website for		
6		informational purposes only;		
7	(4)	Reviewing and approving, as needed, any alternative		
8		test methods or fire standard compliance markings		
9		submitted by the manufacturer; and		
10	(5)	If needed, submitting certified cigarettes to an		
11		accredited laboratory for testing to verify that		
12		performance standards have been met.		
13	<u>(c)</u>	Moneys in the reduced ignition propensity cigarette		
14	program special fund may also be administered and expended by			
15	the state fire council to defray the costs, including the costs			
16	of employing administrative personnel, of statewide fire			
17	prevention, education, safety, and preparedness programs,			
18	especially as they relate to youth, seniors, and persons with			
19	disabilities."			
20	SECTION 3. Statutory material to be repealed is bracketed			
21	and stricken. New statutory material is underscored.
