A BILL FOR AN ACT

RELATING TO FIREARMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that a "ghost gun" is a			
2	firearm that is assembled without serial numbers or other			
3	identification markings. A person may assemble a ghost gun from			
4	a prepackaged kit requiring only minimal expertise and thus			
5	bypass background checks, registration, and other legal			
6	requirements. The legislature also finds that the State's lack			
7	of laws addressing ghost guns allows persons who would normally			
8	be prohibited under state law from owning or possessing firearms			
9	to do so. The ease with which ghost guns may be obtained			
10	defeats the intent of the State's otherwise strict firearm			
11	permitting and registration laws. It is these laws that have			
12	helped Hawaii to achieve the lowest gun violence death rate in			
13	the nation.			
14	Accordingly, the purpose of this Act is to:			
15	(1) Prohibit the purchase, manufacture, or obtaining of			
16	firearm parts for the purpose of assembling a firearm			

having no serial number; and

1	(2) Amend certain requirements relating to firearms
2	registration.
3	SECTION 2. Chapter 134, Hawaii Revised Statutes, is
4	amended by adding a new section to part I to be appropriately
5	designated and to read as follows:
6	"§134- Manufacturing or purchasing firearm parts to
7	assemble a firearm having no serial number; penalty. (a) A
8	person who is not licensed to manufacture a firearm under
9	section 134-31, or who is not a dealer licensed by the United
10	States Department of Justice, shall not, for the purpose of
11	assembling a firearm, purchase, produce with a three-dimensional
12	printer, or otherwise obtain separately, or as part of a kit:
13	(1) A firearm receiver that is not imprinted with a serial
14	number registered with a federally licensed
15	manufacturer;
16	(2) A firearm receiver that has not been provided a serial
17	number that may be registered in accordance with
18	section 134-3(c); or
19	(3) Any combination of parts from which a firearm having
20	no serial number may be readily assembled; provided

1 that the parts do not have the capacity to function as 2 a firearm unless assembled. 3 (b) Violation of this section is a class C felony." SECTION 3. Section 134-1, Hawaii Revised Statutes, is 4 amended by adding three new definitions to be appropriately 5 6 inserted and to read as follows: 7 ""Assembly" means the fabrication of a firearm or the 8 fitting together of component parts to construct a firearm. 9 "Firearm receiver" means the part of a firearm that 10 provides housing for the firearm's internal components, such as 11 a hammer, bolt, breechblock, action, or firing mechanism. The 12 term includes any object or part that is not a firearm frame or 13 receiver in finished form but that is designed or intended to be 14 used for that purpose and may readily be made into a firearm 15 frame or receiver through milling or other means. 16 "Ghost gun" means a firearm that is assembled without a 17 serial number or other identification marking." 18 SECTION 4. Section 134-3, Hawaii Revised Statutes, is 19 amended by amending subsections (a) through (d) to read as 20 follows:

1	"(a) Every <u>resident or</u> person arriving in the State who				
2	brings or by any other manner causes to be brought into the				
3	State a firearm of any description, whether usable or unusable,				
4	serviceable or unserviceable, modern or antique, shall register				
5	the firearm within five days after arrival of the person or of				
6	the firearm, whichever arrives later, with the chief of police				
7	of the county of the person's place of business or, if there is				
8	no place of business, the person's residence or, if there is				
9	neither a place of business nor residence, the person's place of				
10	sojourn. A nonresident alien may bring firearms not otherwise				
1	prohibited by law into the State for a continuous period not to				
12	exceed ninety days; provided that the person meets the				
13	registration requirement of this section and the person				
14	possesses:				
15	(1) A valid Hawaii hunting license procured under chapter				
16	183D, part II, or a commercial or private shooting				
17	preserve permit issued pursuant to section 183D-34;				
18	(2) A written document indicating the person has been				
0	invited to the State to shoot on private land, or				

1	(3) Written notification from a firing range or target		
2	shooting business indicating that the person will		
3	actually engage in target shooting.		
4	The nonresident alien shall be limited to a nontransferable		
5	registration of not more than ten firearms for the purpose of		
6	the above activities.		
7	Every person registering a firearm under this subsection		
8	shall be fingerprinted and photographed by the police department		
9	of the county of registration; provided that this requirement		
10	shall be waived where fingerprints and photographs are already		
11	on file with the police department. The police department shall		
12	perform an inquiry on the person by using the International		
13	Justice and Public Safety Network, including the United States		
14	Immigration and Customs Enforcement query, the National Crime		
15	Information Center, and the National Instant Criminal Background		
16	Check System, pursuant to section 846-2.7 before any		
17	determination to register a firearm is made. Any person		
18	attempting to register a firearm, a firearm receiver, or the		
19	parts used to assemble a firearm, and who is found to be		
20	diagnalified from ownership, possession, or control of firearms		

1 or ammunition under section 134-7, shall surrender or dispose of 2 all firearms and ammunition pursuant to section 134-7.3. 3 (b) Every person who acquires a firearm pursuant to 4 section 134-2 shall register the firearm in the manner 5 prescribed by this section within five days of acquisition. The 6 registration of all firearms shall be on forms prescribed by the 7 attorney general, which shall be uniform throughout the State, 8 and shall include the following information: name of the 9 manufacturer and importer; model; type of action; caliber or 10 gauge; serial number; and source from which receipt was 11 obtained, including the name and address of the prior 12 registrant. If the firearm has been assembled from separate 13 parts and an unfinished firearm receiver, the entity that 14 registered the firearm receiver shall be recorded in the space 15 provided for the name of the manufacturer and importer, and the 16 phrase "assembled from parts" shall be recorded in the space 17 provided for model. If the firearm has been assembled from 18 parts created using a three-dimensional printer, the entity that 19 registered the firearm receiver shall be recorded in the space 20 provided for the name of the manufacturer and importer, and the 21 phrase "3-D printer" shall be recorded in the space provided for

- 1 model. If the firearm has no serial number, the [permit]
- 2 registration number shall be entered in the space provided for
- 3 the serial number, and the [permit] registration number shall be
- 4 engraved upon the receiver portion of the firearm before
- 5 registration. On firearms assembled from parts created using a
- 6 three-dimensional printer, the serial number shall be engraved
- 7 on stainless steel and permanently embedded to the firearm
- 8 receiver during fabrication or construction. All registration
- 9 data that would identify the individual registering the firearm
- 10 by name or address shall be confidential and shall not be
- 11 disclosed to anyone, except as may be required:
- 12 (1) For processing the registration;
- 13 (2) For database management by the Hawaii criminal justice
- 14 data center;
- 15 (3) By a law enforcement agency for the lawful performance
- of its duties; or
- 17 (4) By order of a court.
- 18 (c) Dealers licensed under section 134-31 or dealers
- 19 licensed by the United States Department of Justice shall
- 20 register firearms pursuant to this section on registration forms
- 21 prescribed by the attorney general and shall not be required to



- 1 have the firearms physically inspected by the chief of police at
- 2 the time of registration. An authorized dealer, as provided in
- 3 section 134-31, or a dealer licensed by the United States
- 4 Department of Justice, who brings, assembles, or causes to be
- 5 brought into the State by any other means, separate parts and an
- 6 unfinished firearm receiver that when assembled create a
- 7 firearm, or parts created by a three-dimensional printer which
- 8 when assembled create a firearm, shall register the unfinished
- 9 firearm receiver and receive a serial number before the assembly
- 10 of the firearm or the sale or transfer of unassembled firearm
- 11 parts or a receiver to a third party, in accordance with
- 12 subsection (b). Any sale or transfer of unfinished firearm
- 13 receivers by an authorized dealer to a third party shall be
- 14 conducted as if they were fully assembled firearms with a serial
- 15 number engraved on the firearm receiver and in accordance with
- 16 the firearms permitting process in section 134-2. All other
- 17 firearms and firearm receivers registered under this section
- 18 shall be physically inspected by the respective county chief of
- 19 police or the chief's representative at the time of
- 20 registration.
- 21 (d) Registration shall not be required for:

1	(1)	Any device that is designed to fire loose black powder	
2		or that is a firearm manufactured before 1899;	
3	(2)	Any device not designed to fire or made incapable of	
4		being readily restored to a firing condition; or	
5	(3)	All unserviceable firearms and destructive devices	
6		registered with the Bureau of Alcohol, Tobacco, [and]	
7		Firearms, and Explosives of the United States	
8		Department of Justice pursuant to Title 27, Code of	
9		Federal Regulations."
