### A BILL FOR AN ACT

RELATING TO REGISTRATION OF VEHICLES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that some individuals and
- 2 entities intentionally abandon vehicles on roads and highways
- 3 throughout the State, leaving the counties to bear the
- 4 burdensome costs of towing, removal, and disposal of these
- 5 vehicles. The legislature believes that the counties should be
- 6 authorized to recoup towing, removal, and disposal costs from
- 7 vehicle owners.
- 8 Accordingly, the purpose of this Act is to authorize the
- 9 director of finance of each county to require that the owner of
- 10 an abandoned vehicle repay the county for any towing, removal,
- 11 or disposal costs incurred for that vehicle as a condition to
- 12 receiving a certificate of vehicle registration or authorizing
- 13 the transfer of certain vehicles.
- 14 SECTION 2. Section 286-51, Hawaii Revised Statutes, is
- 15 amended by amending subsection (a) to read as follows:
- 16 "(a) The certificate of registration for each motor
- 17 vehicle in the counties of the State shall be renewed on a

- 1 staggered basis as established by each county. The director of
- 2 finance of each county may adopt rules to carry out the purposes
- 3 stated in this section and shall expend the necessary funds from
- 4 the director's operating funds as may be necessary for these
- 5 purposes; provided that [the director of finance,] if the
- 6 director has ascertained as of the date of the application that
- 7 the registered owner has not deposited or paid bail with respect
- 8 to any summons or citation issued to the registered owner for
- 9 stopping, standing, or parking in violation of traffic.
- 10 ordinances within the county, or has any outstanding charges
- 11 owed to the county for the towing, removal, or disposal of an
- 12 abandoned or derelict vehicle registered to that owner within
- 13 the county, the director of finance may require, as a condition
- 14 precedent to the renewal, that the registered owner deposit or
- 15 pay bail with respect to all [such] relevant summonses or
- 16 citations [-], or pay the county any outstanding charges, as
- 17 applicable. The certificates of registration issued hereunder
- 18 shall show, in addition to all information required under
- 19 section 286-47, the serial number of the tag or emblem and shall
- 20 be valid during the registration year only for which they are
- 21 issued. The certificates of ownership need not be renewed

- 1 annually but shall remain valid as to any interest shown therein
- 2 until canceled by the director of finance as provided by law or
- 3 replaced by new certificates of ownership as hereinafter
- 4 provided."
- 5 SECTION 3. Section 286-52, Hawaii Revised Statutes, is
- 6 amended by amending subsection (c) to read as follows:
- 7 "(c) Subsection (b), requiring a transferee to forward the
- 8 certificate of ownership after endorsement to the director of
- 9 finance, shall not apply to the transferee of a vehicle who was
- 10 not intending to and does not drive the vehicle or permit the
- 11 vehicle to be driven upon the public highways, but [every such
- 12 transferee, each of these transferees, upon transferring the
- 13 transferee's interest or title to another, shall give notice of
- 14 the transfer to the director of finance and endorse the
- 15 certificate of ownership to the new legal owner and the
- 16 certificate of registration to the new owner; provided that if
- 17 the director of finance has ascertained as of the date of the
- 18 application that the registered owner has not deposited or paid
- 19 bail with respect to any summons or citation issued to the
- 20 registered owner for stopping, standing, or parking in violation
- 21 of traffic ordinances within the county, or has any outstanding

- 1 charges owed to the county for the towing, removal, or disposal
- 2 of an abandoned or derelict vehicle registered to that owner
- 3 within the county, the director may require, as a condition
- 4 precedent to the transfer, that the registered owner deposit or
- 5 pay bail with respect to all [such] relevant summons [or],
- 6 citations [-], or pay the county any outstanding charges, as
- 7 applicable."
- 8 SECTION 4. Statutory material to be repealed is bracketed
- 9 and stricken. New statutory material is underscored.
- 10 SECTION 5. This Act shall take effect on July 1, 2020.
