 into any contracts necessary to operate and maintain the system
 while positions are filled.

8 (d) The department of agriculture shall deposit all fees

(e) The three-year water licensing deadline may be extended for up to two years; provided that the applicant demonstrates significant progress in the permit application process.

SECTION 2. All appropriations, records, equipment, machines, files, supplies, contracts, books, papers, documents, maps, and other property heretofore made, used, acquired, or held by the east Kauai water users' cooperative relating to the functions transferred to the department of agriculture shall be transferred with the functions to which they relate and listed and described in a full accounting to the department.
