A BILL FOR AN ACT

RELATING TO HAWAIIAN HOMELANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 210D, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§210D- Micro enterprise assistance program on Hawaiian
5	home lands revolving fund; established. (a) There is
6	established in the state treasury the micro enterprise
7	assistance program on Hawaiian home lands revolving fund, into
8	which shall be deposited:
9	(1) Appropriations from the legislature;
10	(2) Federal grants and subsidies to the State;
11	(3) Private investments; and
12	(4) Voluntary contributions.
13	(b) Moneys in the micro enterprise assistance program on
14	Hawaiian home lands revolving fund shall be used to provide
15	grants and loans to the following recipients through the
16	implementation of the micro enterprise assistance program:

14	year 2021	-2022 for deposit into the micro enterprise assistance	
15	program on Hawaiian home lands revolving fund.		
16	SECTION 3. There is appropriated out of the micro		
17	enterprise assistance program on Hawaiian home lands revolving

19	necessary	for fiscal year 2020-2021 and the same sum or so much
