A BILL FOR AN ACT

RELATING TO SAFETY EQUIPMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Chapter 302A, Hawaii Revised Statutes, is 1
- 2 amended by adding a new subpart to part II to be appropriately
- 3 designated and to read as follows:
- 4 . ATHLETIC EQUIPMENT
- §302A-A Football helmet safety requirements. (a) 5
- 6 department school shall ensure that each non-new football helmet
- 7 used in that school's football program is reconditioned and
- 8 recertified at least once every two years.
- 9 (b) At the start of each football game played, the
- 10 department school's football team shall present each player's
- 11 helmet to the applicable official referee of the game for
- 12 inspection. If the referee determines that a helmet has not
- 13 been properly recertified in conformance with this section, the
- 14 referee shall retain the helmet until the game has ended;
- 15 provided that the team member to whom the helmet is assigned
- 16 shall be prohibited from participating in that game; provided
- 17 further that if the referee determines that three or more

- 1 helmets fail to conform to the requirements of this section at
- 2 the start of a single game, the department school shall be fined
- 3 not less than \$300 but no more than \$500 per game, depending on
- 4 the number of helmets in violation of this section.
- 5 (c) Any fines collected pursuant to subsection (b) shall
- 6 be:
- 7 (1) Due and payable within thirty days; and
- 8 (2) Deposited into the football helmet recertification
- 9 special fund.
- 10 (d) As used in this section:
- 11 "Recertification" means the process of reconditioning,
- 12 testing, and properly labeling helmets and other athletic
- 13 equipment that meet the original performance standards for that
- 14 equipment.
- 15 "Reconditioning" means the process of inspecting, cleaning,
- 16 sanitizing, repairing, and restoring helmets and other athletic
- 17 equipment to meet the original performance standards for that
- 18 equipment.
- 19 "Referee" means the head official in charge of monitoring a
- 20 particular football game.

- 2 There is established within the state treasury a football helmet
- 3 recertification special fund to be administered by the
- 4 department and into which shall be deposited all moneys
- 5 collected pursuant to section 302A-A.
- 6 Moneys deposited into the football helmet
- 7 recertification special fund may be expended by the department
- 8 for costs and expenses related to the administration and
- 9 operation of athletic programs at department schools."
- 10 SECTION 2. This Act does not affect rights and duties that
- 11 matured, penalties that were incurred, and proceedings that were
- 12 begun before its effective date.

13 SECTION 3. This Act shall take effect on July 1, 2020.

Report Title:

DOE; Athletics; Football; Helmets; Recertification; Reconditioning; Football Helmet Recertification Special Fund; Fines

Description:

Requires Department of Education school football programs to ensure that each non-new football helmet used in a football program is reconditioned and recertified at least once every 2 years. Establishes fines and other penalties for failure to properly recertify football helmets. Establishes the football helmet recertification special fund.
