A BILL FOR AN ACT

RELATING TO STATE PROCUREMENT OF WIFI AND INTERNET SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that today's internet is
- 2 full of pornographic content. A simple web search leads to a
- 3 plethora of results to both free and paid websites. While non-
- 4 violent pornography exists, it is not the norm. Pornography
- 5 often involves women or children being coerced or treated
- 6 brutally during sexual intercourse. Both psychological and
- 7 sociological theories suggest that violence is the result of
- 8 learned behavior, and frequent viewing of materials depicting
- 9 sexual violence against women or children could in fact lead
- 10 some to believe this behavior is acceptable thereby perpetuating
- 11 the violence.
- 12 The federal government requires all public schools and
- 13 libraries receiving federal funds and provide internet access to
- 14 use filters that block people from accessing pornography at
- 15 those sites. Technological advances now allow people to access
- 16 the internet via WiFi on their personal portable devices.

- 1 Consequently, state facilities that provide free WiFi are also
- 2 providing unfettered access to pornography at taxpayer expense.
- 3 The legislature further finds that the State has a
- 4 legitimate interest in protecting children and preserving our
- 5 family-friendly tourist reputation by ensuring they are not
- 6 unwillingly exposed to others nearby watching pornography in a
- 7 state facility, and that state resources are not being utilized
- 8 to obtain pornography. By requiring that all state and state
- 9 funded facilities have internet computer and wireless access
- 10 filters, the State is not interfering with free speech. The
- 11 State is simply ensuring that when the State is a customer and
- 12 purchasing internet access or providing state resources for
- internet access, that it is not providing access to pornography.
- 14 The purpose of this Act is to require that all state and
- 15 state funded facilities have internet computer and wireless
- 16 access filters to block access to pornography sites.
- 17 SECTION 2. Chapter 103D, Hawaii Revised Statutes, is
- 18 amended by adding a new section to part I to be appropriately
- 19 designated and to read as follows:
- 20 "§103D- Internet filters. (a) All state and state
- 21 funded facilities must have internet computer and wireless

- 3 (b) All state agencies shall add contract language and

- 11 SECTION 3. Chapter 103F, Hawaii Revised Statutes, is
- 12 amended by adding a new section to part IV to be appropriately
- 13 designated and to read as follows:
- 14 "§103F- Internet filters. (a) All state and state
- 15 funded facilities must have internet computer and wireless
- 16 access filters that block access to sites that provide
- 17 pornographic images, depictions, or materials.
- 18 (b) All state agencies shall add contract language and
- 19 provisions to state procurement requirements that require
- 20 suppliers of telecommunications, internet, broadband, and data
- 21 communication services to provide the state with filters that

- 1 block access to sites that provide pornographic images,
- 2 depictions, or materials.
- 3 (c) For purposes of this section, "pornographic" shall
- 4 have the same meaning as in section 712-1210."
- 5 SECTION 4. New statutory material is underscored.
- 6 SECTION 5. This Act shall take effect upon its approval.
