A BILL FOR AN ACT

RELATING TO ALZHEIMER'S DISEASE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Alzheimer's is the
- 2 most expensive disease in America, costing more than cancer and
- 3 heart disease. According to the Alzheimer's Association, the
- 4 direct costs to American society of caring for those with
- 5 Alzheimer's and other dementias totaled an estimated
- 6 \$290,000,000,000 in 2019. The average costs of caring for a
- 7 person with dementia are \$287,000 during the last five years of
- 8 life. This compares with \$175,000 for a person with heart
- 9 disease and \$173,000 for someone with cancer.
- The legislature also finds that, according to the 2019
- 11 Alzheimer's Disease Facts and Figures Report published by the
- 12 Alzheimer's Association, in Hawaii, the medicaid costs of caring
- 13 for people with Alzheimer's disease totaled \$232,000,000 in
- 14 2019, with \$17,965 in per capita medicare spending, and unpaid
- 15 caregiver time valued at \$941,000,000.
- 16 Less than one per cent of those diagnosed with Alzheimer's
- 17 disease receive comprehensive care planning services, despite



- 1 those services being eligible under medicaid and medicare.
- 2 Persons diagnosed with Alzheimer's disease and other dementias
- 3 who engage in comprehensive care planning can reduce their
- 4 financial burden and significantly improve their overall quality
- 5 of life.
- 6 The legislature further finds that consultation with
- 7 medical professionals will enable more people to adequately plan
- 8 for comprehensive care after being diagnosed with Alzheimer's
- 9 disease and related dementias.
- 10 The purpose of this Act is to establish an outreach program
- in the department of health to inform medical professionals
- 12 participating in medicare that comprehensive care planning
- 13 services for those with Alzheimer's disease and related
- 14 dementias is a covered benefit under the medicare program.
- 15 SECTION 2. The department of health shall establish an
- 16 outreach program to conduct a comprehensive, one-time education
- 17 initiative informing physicians and appropriate non-physician
- 18 practitioners participating in the medicare program that
- 19 comprehensive care planning services for those with Alzheimer's
- 20 disease and related dementias is a covered benefit under the
- 21 medicare program. The outreach program shall include:

11	SECTION 3. There is appropriated out of the general		
12	revenues	of the State of Hawaii the sum of \$ or so	
13	much thereof as may be necessary for fiscal year 2020-2021 for		
14	the outreach program established pursuant to this Act.		
15	The sum appropriated shall be expended by the department o		
16	health for the purposes of this Act.		
17	SECT	ION 4. This Act shall take effect on July 1, 2050.
