### A BILL FOR AN ACT

RELATING TO INVASIVE SPECIES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the invasion of
- 2 Hawai'i by insects, disease-bearing organisms, snakes, weeds, and
- 3 other pests is the single greatest threat to the State's economy
- 4 and natural environment and to the health and lifestyle of the
- 5 people of Hawai'i. Pests already cause millions of dollars in
- 6 crop losses, the extinction of native species, the destruction
- 7 of native forests, and the spread of disease, but many more
- 8 harmful pests now threaten to invade Hawai'i and cause more
- 9 damage. Stopping the influx of new pests and containing their
- 10 spread are essential to the State's current and future well-
- 11 being.
- 12 The legislature further recognizes the efforts made by the
- 13 department of land and natural resources' division of forestry
- 14 and wildlife, Maui branch, and the Maui invasive species
- 15 committee to control high-threat invasive species throughout
- 16 Maui county, especially efforts in east Maui to control miconia,
- 17 a fast-growing weedy tree that can increase erosion and

- 1 landslides due to its shallow root system. It is estimated that
- 2 approximately 37,000 acres throughout east Maui could contain
- miconia, which poses a threat to the local environment, cultural 3
- 4 practices, and economy.
- 5 The purpose of this Act is to provide funds to establish
- 6 invasive species technician positions for the department of land
- 7 and natural resources' division of forestry and wildlife in east
- 8 Maui to control invasive species, like miconia, from negatively
- 9 impacting the environment and economy.
- 10 SECTION 2. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$500,000 or so much
- 12 thereof as may be necessary for fiscal year 2020-2021 for
- 13 establishing five permanent full-time equivalent (5.0 FTE)
- 14 invasive species technician positions at the department of land
- 15 and natural resources' division of forestry and wildlife, Maui
- 16 branch, to address invasive plants and animals in east Maui.
- 17 The sum appropriated shall be expended by the department of
- 18 land and natural resources for the purposes of this Act.
- 19 SECTION 3. This Act shall take effect on July 1, 2020.
