A BILL FOR AN ACT

RELATING TO HAWAIIAN HOME LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the department of
- 2 Hawaiian home lands and the office of Hawaiian affairs are vital
- 3 to the well-being and financial autonomy of the native Hawaiian
- 4 community. Providing the many important services to native
- 5 Hawaiian residents requires sufficient funds as mandated by the
- 6 Hawaii Constitution and the Hawaii Revised Statutes.
- 7 The legislature further finds that the department of
- 8 Hawaiian home lands funding mandate arises from article XII,
- 9 section 1 of the Hawaii Constitution, which states in pertinent
- 10 part that the legislature shall make sufficient sums available
- 11 for the administration and operating budget of the department.
- 12 The legislature notes that in Nelson v. Hawaiian Homes
- 13 Commission, 127, Hawaii 195, 277 P.3d 279 (2012), the supreme
- 14 court of the State of Hawaii determined that the State had not
- 15 provided sufficient funding to the department as required by the
- 16 state constitution.

1	The legislature also finds that the office of Hawaiian
2	affairs is similarly charged with administration of programs
3	that benefit native Hawaiians. In accordance with section
4	10-13.5, Hawaii Revised Statutes, the State is obligated to
5	provide the office of Hawaiian affairs with twenty per cent of
6	the funds derived from the public land trust.
7	The purpose of this Act is to appropriate, from the general
8	fund:
9	(1) An amount equal to the budget request (for operating
10	and administrative expenses) that is annually
11	submitted by the department of Hawaiian home lands;
12	and
13	(2) An amount equal to twenty per cent of all funds
14	derived from the public land trust as mandated by 10-
15	13.5, Hawaii Revised Statutes.
16	SECTION 2. There is appropriated out of the general
17	revenues of the State of Hawaii the sum of \$ or so
18	much thereof as may be necessary for fiscal year 2020-2021 for
19	operating and administrative expenses of the department of
20	Hawaiian home lands.

- 1 The sum appropriated shall be expended by the department of
- 2 Hawaiian home lands for the purposes of this Act.
- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so
- 5 much thereof as may be necessary for fiscal year 2020-2021
- 6 pursuant to section 10-13.5, Hawaii Revised Statutes.
- 7 The sum appropriated shall be expended by the office of
- 8 Hawaiian affairs for the purposes of this Act.
- 9 SECTION 4. This Act shall take effect on July 1, 2020.
