## A BILL FOR AN ACT

RELATING TO TRAFFIC VIOLATIONS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 291-14, Hawaii Revised Statutes, is 2 amended as follows: 1. By amending subsection (a) to read: 3 "(a) No person shall stand in the bed or load-carrying 4 area of any motor vehicle commonly known as a pickup truck while 5 the vehicle is in operation. No operator of any pickup truck 6 7 shall operate the vehicle with a passenger seated in the bed or 8 load-carrying area of the vehicle unless[+ 9 (1) There is no seating available in the cab of the 10 vehicle; (2) The side racks of the vehicle-are securely attached 11 12 and the tailboard or tailgate is securely closed; (3) Every passenger in the bed or load-carrying area of 13 the vehicle is seated on the floor and does not 14 15 attempt to control unlashed cargo.] exempt under subsection (c)." 16

By amending subsections (c) and (d) to read:

1	"(c) No operator of any pickup truck may operate the
2	vehicle with any passenger [twelve years of age or under] in the
3	bed or load-carrying area of the vehicle, unless one of the
4	following applies:
5	(1) An emergency exists that threatens the life of the
6	passenger being transported in the bed or load-
7	carrying area of the vehicle; or
8	(2) The vehicle is being operated in parades, caravans, or
9	exhibitions [which] that are officially authorized or
10	otherwise permitted by law.
11	(d) Any person who violates this section shall be subject
12	to a fine of \$25 for each violation[; provided that any person
13	who violates subsection (c) shall be subject to a fine of \$50
14	for each separate violation]."
15	SECTION 2. Statutory material to be repealed is bracketed
16	and stricken. New statutory material is underscored.
17	SECTION 3. This Act shall take effect upon its approval.

# S.B. NO. 2401

### Report Title:

Traffic Violations; Pickup Trucks; Passenger Restrictions

### Description:

Repeals several exemptions from the prohibition on operating a pickup truck with a passenger seated in the bed or load-carrying area, including the exemption that allows passengers over twelve years of age to ride in the bed or load-carrying area. Reduces the fine for violating the prohibition.
