A BILL FOR AN ACT

RELATING TO NON-AGRICULTURAL PARK LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 90, Session Laws of Hawaii 2003, was 2 enacted and codified as chapter 166E, Hawaii Revised Statutes, 3 to transfer certain non-agricultural park lands from the department of land and natural resources to the department of 4 5 agriculture. The legislature finds that many lessees, primarily 6 farmers and ranchers, with large acreage of land have already been notified by the department of agriculture that their land 7 8 leases were to be transferred to and managed by the department 9 of agriculture. However, nearly seventeen years later, the 10 department of land and natural resources has not yet transferred 11 the land.

12 The purpose of this Act is to:

13 (1) Set a deadline for the transfer of certain non14 agricultural park lands from the department of land
15 and natural resources to the department of agriculture
16 pursuant to Act 90, Session Laws of Hawaii 2003; and

1	(2) Clarify that the care and production of pasture land
2	constitutes an "agricultural activity" for purposes of
3	chapter 166E, Hawaii Revised Statutes.
4	SECTION 2. Chapter 166E, Hawaii Revised Statutes, is
5	amended by adding a new section to be appropriately designated
6	and to read as follows:
7	"§166E- Transfer to department of agriculture;
8	deadline. (a) Any provision of this chapter to the contrary
9	notwithstanding, the department of land and natural resources
10	shall transfer lands to the department by June 30, 2020, as
11	provided in subsection (b).
12	(b) Any provision of this chapter to the contrary
13	notwithstanding, any lands identified and approved for
14	unconditional transfer as non-agricultural park lands that have
15	not been transferred by June 30, 2020, shall be placed under the
16	jurisdiction of the department by July 1, 2020. The department
17	of land and natural resources shall be responsible for all
18	leases and agreements that are not in compliance with section
19	166E-3. The department shall assume responsibility for
20	compliant leases and agreements and shall negotiate future
21	leases and agreements by July 1, 2020."

1 SECTION 3. Section 166E-2, Hawaii Revised Statutes, is amended by amending the definition of "agricultural activities" 2 3 to read as follows: ""Agricultural activities" means the care and production of 4 5 livestock, livestock products, poultry, or poultry products, or apiary, horticultural, or floricultural products, or the 6 7 planting, cultivating, and harvesting of crops or trees. As 8 used in this definition, the care and production of livestock or 9 livestock products includes the care and production of pasture 10 land." 11 SECTION 4. The department of land and natural resources 12 and department of agriculture shall jointly submit a report to 13 the legislature no later than twenty days prior to the convening 14 of the regular session of 2021, on their efforts to effectuate 15 the land transfer as provided in section 2 of this Act, 16 including a list of all identified land transfers. 17 SECTION 5. This Act does not affect rights and duties that 18 matured, penalties that were incurred, and proceedings that were 19 begun before its effective date. 20 SECTION 6. New statutory material is underscored.
