### A BILL FOR AN ACT

RELATING TO HEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 The legislature finds that women who are
- 2 ineligible for post-partum health coverage struggle to get
- 3 necessary care during the fourth trimester, the twelve weeks
- 4 following childbirth. The legislature notes that these twelve
- 5 weeks are a critical time as women are more likely to die of
- 6 pregnancy-related conditions during this time than during
- 7 pregnancy or childbirth. Nationwide, drug overdoses, suicides
- 8 and pregnancy-related chronic illnesses, including diabetes,
- 9 heart disease, and high blood pressure, contribute to a rise in
- 10 deaths among women during pregnancy, childbirth, and the first
- 11 twelve months after childbirth.
- 12 The legislature also finds that according to the United
- 13 States Centers for Disease Control and Prevention, adequate
- 14 medical attention could prevent three out of five post-partum
- 15 deaths. Further, medicaid pregnancy coverage, which pays for
- nearly half of all births in the United States, expires sixty 16
- 17 days after childbirth, leaving many women without health



- 1 insurance during this vulnerable time. Although women may
- 2 reapply as a parent after this sixty-day time period, because
- 3 the income limit for parents is lower, many women are unable to
- 4 qualify for coverage as a parent. However, policymakers in at
- 5 least six states, including California, Illinois, Missouri, New
- 6 Jersey, South Carolina, and Tennessee, are working to extend
- 7 medicaid coverage to a full year after childbirth.
- 8 Additionally, health agencies in Georgia, Texas, Utah, and
- 9 Washington recommend similar efforts.
- 10 The legislature acknowledges that, according to the
- 11 Commonwealth Fund, a health care advocacy group, maternal
- 12 mortality rates, including deaths during and up to one year
- 13 after pregnancy, are higher in the United States than in other
- 14 developed nations. Additionally, while pregnancy-related death
- 15 rates have dropped worldwide over the past thirty years, these
- 16 rates have more than doubled in the United States. According to
- 17 the United States Centers for Disease Control and Prevention,
- 18 the number of deaths per one hundred thousand live births in the
- 19 United States has risen from seven in 1987 to seventeen in 2016.
- 20 Accordingly, the purpose of this Act is to provide medical
- 21 assistance for pregnant women in certain circumstances.

1	SECTION 2.	section 346-70, hawaii kevised statutes, is
2	amended to read as follows:

4	women. (a) The	department may provide state-funded medical
5	assistance to a pregnant woman age nineteen years of age or	
6	older whose countable family income does not exceed one hundred	
7	and eighty-five per cent of the federal poverty level for a	
8	family of applicable size, including the expected unborn	
9	children. The pr	regnant woman shall be:
10	(1) A legal	l immigrant who entered the United States on or
11	after A	August 22, 1996; and
12	(2) Otherwi	ise eligible for benefits under the State's
13	medicai	id program but is prohibited from participating
14	in any	medical assistance program under title XIX of
15	the Soc	cial Security Act for a period of five years
16	beginni	ing on the date of her entry into the United
17	States,	, due to restricted eligibility rules imposed by
18	title >	XIX of the Social Security Act and the Personal
19	Respons	sibility and Work [Opportunity] Reconciliation
20	Act of	1996.

1	(b) Once determined eligible for medical assistance under		
2	this section, the pregnant woman shall continue to be eligible		
3	throughout her pregnancy and through the last day of the		
4	calendar month in which the sixty-day period following		
5	childbirth ends.		
6	(c) Any pregnant woman who is ineligible for medical		
7	insurance coverage through her employer or medicaid shall be		
8	eligible for medical assistance under this section for a period		
9	ending twelve months following childbirth.		
10	$[\frac{(c)}{(c)}]$ Assets shall not be evaluated for eligibility		
11	purposes.		
12	$[\frac{(d)}{(e)}]$ The director shall adopt rules pursuant to		
13	chapter 91 to determine eligibility for medical assistance."		
14	SECTION 3. Statutory material to be repealed is bracketed		
15	and stricken. New statutory material is underscored.		
16	SECTION 4. This Act shall take effect upon its approval.
