A BILL FOR AN ACT

RELATING TO HUMAN SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that homelessness
- 2 continues to be one of the State's most significant and
- 3 challenging social problems. Although the Hawaii statewide
- 4 homeless point-in-time count conducted in January 2018 found
- 5 that there are 6,530 homeless individuals in the State, an
- 6 overall decrease of 9.6 per cent from 2017, the costs of caring
- 7 for this population have continued to grow. Many homeless
- 8 persons face a wide range of challenges, including general
- 9 health issues, mental illness, and substance abuse issues.
- 10 These problems affecting homeless persons also impact the
- 11 general population through the costs of social and health care
- 12 services. In 2016, homeless persons in the State made more than
- 13 twenty thousand hospital visits. In 2016, state hospitals
- 14 billed \$214,000,000 in charges for caring for the homeless, up
- 15 drastically from \$70,500,000 in 2010. Treatment for these
- 16 homeless individuals is sometimes uncompensated; one hospital

- 1 alone estimates it incurs more than \$10,000,000 in uncompensated
- 2 costs annually.
- 3 The legislature also finds that mobile clinics have become
- 4 increasingly popular across the nation as state governments try
- 5 to find ways to address the health care needs of homeless
- 6 populations. In places like Dallas, Texas; Denver, Colorado;
- 7 San Jose, California; and Seattle, Washington, mobile clinics
- 8 offer a variety of free health care services for local homeless
- 9 populations, resulting in significant cost savings when compared
- 10 to emergency room visits. One estimate from 2016 found that
- 11 each dollar spent on mobile clinics saved twelve dollars in
- 12 other costs.
- 13 The purpose of this Act is to appropriate funds for
- 14 purchasing, staffing, and operating mobile clinics to
- 15 serve homeless individuals; provided that of the
- 16 mobile clinics shall be allocated to the county with the largest
- 17 land mass.
- 18 SECTION 2. The department of human services shall contract
- 19 with nonprofits to establish and operate mobile
- 20 clinics to serve homeless individuals; provided that:

1	(1)	mobile clinic shall be allocated to the

3	(2)	No funds shall be made available under this Act unless		
4		the department of human services first obtains		
5		matching funds on a dollar-for-dollar basis to the		
6		amount appropriated by the State;		
7	(3)	Mobile clinic staff may include a primary care		
8		provider, a nurse, a pharmacist, a psychiatrist, a		
9		psychologist, a social worker, an outreach worker,		
10		students pursuing degrees in medicine or nursing, and		
11		other staff as needed; and		
12	(4)	The mobile clinics may provide, at a minimum, the		
13		following services:		
14		(A) Non-emergency medical services for chronic,		
15		acute, and episodic conditions;		
16		(B) Testing for sexually transmitted disease, human		
17		immunodeficiency virus, and hepatitis;		
18		(C) Family planning;		
19		(D) Child and family services;		
20		(E) Behavioral health and substance abuse services;		
21		(F) Mental health services;

13	SECTION 3	. There is approp	riated out of the ge	eneral	
14	revenues of th	e State of Hawaii	the sum of \$	or so much	
15	thereof as may be necessary for fiscal year 2020-2021 to				
16	purchase, staff, and operate mobile clinics to serve				
17	homeless individuals pursuant to this Act.				
18	The sum appropriated shall be expended by the department of				
19	human services for the purposes of this Act.				
20	SECTION 4	. This Act shall	take effect on July	1, 2050.
