A BILL FOR AN ACT

RELATING TO PROTECTIVE ORDERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that promoting the safety
- 2 of persons granted long-term protective orders is inherent in
- $\overline{3}$ the objective of the orders. The legislature further finds that
- 4 the current method by which protected individuals can prove the
- 5 existence of an order is cumbersome. Protected individuals,
- 6 including young minors, need to carry the nine-page documents at
- 7 all times. Doing so is not only inconvenient, but may quickly
- 8 render the order illegible due to wear and tear.
- 9 The legislature believes that a better alternative has been
- 10 implemented in other states: the option to carry an
- 11 identification card the size of a driver's license that provides
- 12 all the information needed for law enforcement agencies to
- 13 verify a long-term protective order's existence. The
- 14 legislature finds that these types of cards, known as "hope
- 15 cards, " are durable, waterproof, and easily portable. The
- 16 cards' functionality serves to increase the safety of the

- 1 persons protected by these orders by making it easy to carry
- 2 proof of protection on a daily basis.
- 3 The program shall be responsible for issuing hope cards to
- 4 grantees of a long-term protective order, at a grantee's
- 5 request, for the purpose of allowing law enforcement agencies to
- 6 quickly verify the existence of, and more easily obtain
- 7 information on, the long-term protective order. It is the
- 8 legislature's intent that hope cards provide a more convenient
- 9 method by which protected individuals can prove that a
- 10 protective order is in place. The legislature does not intend
- 11 that the cards replace the original protective orders granted by
- 12 the court.
- 13 Accordingly, the purpose of this Act is to establish a
- 14 Hawaii hope card program within the department of the attorney
- 15 general.
- 16 SECTION 2. Chapter 28, Hawaii Revised Statutes, is amended
- 17 by adding a new part to be appropriately designated and to read
- 18 as follows:

2	§28-	Hawaii hope card program. (a) There is

5	(b)	Any person who has been granted a long-term protective
6	order may	request a hope card by submitting an application to
7	the depar	tment of the attorney general on a form prescribed by
8	the depar	tment. After verifying the validity of the long-term
9	protective order upon which the application is based, the	
10	department of the attorney general shall issue a hope card to	
11	the applicant; provided that duplicate hope cards may be issued	
12	to an app	licant upon request as necessary, including in the
13	following	situations:
14	(1)	For the applicant to provide the hope card to a school
15		or employer;
16	(2)	To enable use of the hope card by a child or other
17		individual covered by the long-term protective order;
18		or
19	(3)	For the applicant to provide the hope card to a
20		school, day care program, or other similar institution

1		attended by a child or other individual covered by the
2		long-term protective order.
3	(c)	A hope card shall be similar in size and material to a
4	Hawaii st	ate driver's license, display a color photograph of the
5	person to	be restrained by the long-term protective order, if
6	available	and confirmed by the court issuing the long-term
7	protectiv	e order, and contain essential information if provided
8	within th	e long-term protective order, including:
9	(1)	Identifying characteristics of the person to be
10		restrained, including name, date of birth, sex, race,
11		eye and hair color, height, weight, and any
12		distinguishing features such as scars or tattoos;
13	(2)	The case number and the issuing court of the long-term
14		protective order;
15	(3)	The issuance and expiration dates of the long-term
16		protective order;
17	(4)	Identifying characteristics of the applicant,
18		including name, date of birth, sex, race, eye and hair
19		color, height, and weight; and

- 4 (d) Hope cards and duplicates shall be issued at no charge 5 to applicants.
- 6 (e) For the purposes of this part, "long-term protective
 7 order" means a protective order that is to remain in effect for
 8 a period of more than ninety days under section 604-10.5, or for
 9 a period of more than one hundred eighty days under chapter 586.
- 10 §28- Access to Hawaii hope card program information;
- 11 verification. (a) The Hawaii hope card program shall notify
- 12 the Hawaii criminal justice data center when a hope card has
- 13 been issued regarding a protective order. This information
- 14 shall be made available to law enforcement personnel seeking to
- 15 verify the validity of the hope card or its underlying
- 16 protective order.
- 17 (b) Access authorized by this section may be provided in
- 18 coordination with the Hawaii criminal justice data center
- 19 established under chapter 846.

- 1 §28- Prohibitions; penalty. (a) No hope card applicant
- 2 or program participant shall knowingly provide false, information
- 3 on an initial application or renewal application.
- 4 (b) An applicant or program participant who violates this
- 5 section shall be fined not more than \$500.
- 6 §28- Rulemaking authority. The attorney general shall
- 7 adopt rules pursuant to chapter 91 as necessary to carry out the
- 8 purposes of this part."
- 9 SECTION 3. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of or so much
- 11 thereof as may be necessary for fiscal year 2020-2021 for the
- 12 department of the attorney general to administer the Hawaii hope
- 13 card program.
- 14 The sum appropriated shall be expended by the department of
- 15 the attorney general for the purposes of this Act.
- 16 SECTION 4. No later than January 1, 2021, the department
- 17 of the attorney general shall develop and implement the Hawaii
- 18 hope card program that is established by section 2 of this Act.
- 19 SECTION 5. This Act shall take effect on July 1, 2050.
