BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 481J-2, Hawaii Revised Statutes, is

- 4 "(a) No used motor vehicle shall be sold in this State by
- 5 a dealer to a consumer unless accompanied by at least two
- 6 operable sets of keys, including key fobs, at the time of sale
- 7 and a written warranty covering the full cost of both parts and
- 8 labor necessary to repair any defect or malfunction in a part
- 9 covered under subsection (c) that impairs the used motor
- 10 vehicle's safety or use. Defects and malfunctions that affect
- 11 only appearance shall not be deemed to impair safety or use for
- 12 the purposes of this chapter."
- 2. By amending subsection (c) to read:
- "(c) The written warranty shall require the dealer or its
- 15 agent to repair or, at the election of the dealer, reimburse the
- 16 consumer for the reasonable costs of repairing the failure of or

- 4 SECTION 2. This Act does not affect rights and duties that
- 5 matured, penalties that were incurred, and proceedings that were
- 6 begun before its effective date.
- 7 SECTION 3. Statutory material to be repealed is bracketed
- 8 and stricken. New statutory material is underscored.
- 9 SECTION 4. This Act shall take effect upon its approval.
