BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the security and 1 resilience of Hawaii's critical electrical infrastructure is 2 fundamental to the health and welfare of not only its residents, 3 visitors, and employees, but to the national defense of the 4 5 The legislature acknowledges that modern society country. functions because of safe, affordable, and reliable electrical 6 7 power. However, existing trespassing laws do not provide a proportionate level of protection for such a key resource. 8 9 The purpose of this Act is to protect the public and critical electrical utilities by establishing the offense of 10 trespassing on critical electrical infrastructure. 11 12 SECTION 2. Chapter 708, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated 13 and to read as follows: 14 15 "§708-Criminal trespass on critical electrical

A power generation facility used specifically during (2) 1 times of high demand; 2 (3) An electric transmission facility; 3 An electric station or substation; or 4 (4) Any other facility used to support the generation, 5 (5) transmission, or distribution of electricity. 6 7 "Critical electric infrastructure" does not include support offices, electric transmission land, or right-of-way that is not 8 completely enclosed and maintained by the electric utility." 9 SECTION 4. This Act does not affect rights and duties that 10 11 matured, penalties that were incurred, and proceedings that were begun before its effective date. 12 SECTION 5. New statutory material is underscored. 13 SECTION 6. This Act shall take effect on July 1, 2050. 14
