A BILL FOR AN ACT

RELATING TO THE PENAL CODE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the security and 2 resilience of Hawaii's critical electrical infrastructure is 3 fundamental to the health and welfare of not only its residents, 4 visitors, and employees, but to the national defense of the 5 country. The legislature acknowledges that modern society 6 functions because of safe, affordable, and reliable electrical 7 power. However, existing trespassing laws do not provide a 8 proportionate level of protection for such a key resource.

9 The purpose of this Act is to protect the public and 10 critical electrical utilities by establishing the offense of 11 trespassing on critical electrical infrastructure property.

SECTION 2. Chapter 708, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated and to read as follows:

15 "§708- Criminal trespass on critical electrical
16 infrastructure property. (1) A person commits the offense of
17 criminal trespass on critical electrical infrastructure property

1	when the person intentionally and unlawfully enters or remains
2	on critical electrical infrastructure property with intent to

6	(2) Trespassing on critical electrical infrastructure
7	property is a class C felony."
8	SECTION 3. Section 708-800, Hawaii Revised Statutes, is
9	amended by adding two new definitions to be appropriately
10	inserted and to read as follows:
11	""Critical electrical infrastructure" means facilities,
12	structures, and equipment that are essential for the generation,
13	transmission, or distribution of electricity, including but not
14	limited to:
15	(1) A power plant;
16	(2) A power generation facility used specifically during
17	times of high demand;
18	(3) An electric transmission facility;

9	SECTION 4. This Act does not affect rights and duties that
10	matured, penalties that were incurred, and proceedings that were

13	SECTION 6. This Act shall take effect on July 1, 2050.
