BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 37-77, Hawaii Revised Statutes, is
 amended to read as follows:

3 "§37-77 Claims for legislative relief. (a) All claims 4 for refunds, reimbursements, or other payments, authorization 5 for which is sought from the legislature, shall, as a condition to their being considered by the legislature, be filed with the 6 7 attorney general together with all data and documents in support 8 thereof within six years from the date on which the claim for 9 payment matured. In the absence of a showing of sufficient 10 reason therefor, failure to comply with this paragraph shall be 11 deemed sufficient cause for refusal of the legislature to 12 consider the claims.

13 (b) The attorney general shall, immediately upon receipt 14 thereof, refer any claim and data so received by the attorney 15 general to the agency concerned or the comptroller, and the 16 agency to which the reference is made or the comptroller shall 17 immediately investigate the claim, secure all available data and

documents bearing thereon, and refer the same back to the
 attorney general with its recommendations thereon. The attorney
 general shall review the claim and make a recommendation as to
 the disposition of the claim.

5 (c) The attorney general shall, within five days after the 6 opening of the session, transmit to the legislature the claims 7 which are then recommended for approval in an appropriate 8 legislative bill form, together with an explanation for each 9 claim. Additional recommendations for approval may be 10 transmitted later in the session. All claims for which there is 11 a recommendation of denial shall also be reported to the 12 legislature with an explanation. The data and documents 13 submitted by claimants shall be available for inspection by the 14 legislature.

15 The attorney general shall consult with the governor prior 16 to entering into any settlement agreement for awards exceeding 17 \$75,000 that are subject to legislative approval.

18 (d) For all settlements and judgments for claims against
19 the State, its officers, and employees, that exceed the amounts
20 that may be paid by the comptroller pursuant to section 41D-3,
21 the attorney general shall investigate and determine whether all

1	or a portion of the settlement or judgment should be paid out of
2	the affected department's or departments' operating budget, or
3	out of the general fund, and advise the legislature of its
4	recommendation for each claim. In making this recommendation,
5	the attorney general shall consider how the department's actions
6	or inactions affected the event that resulted in the legal
7	dispute. In addition, the attorney general may consider the
8	size of the department's budget compared to the settlement or
9	judgement amount. The attorney general's recommendations shall
10	be deemed a confidential and privileged communication to the
11	legislature and shall not be disclosed pursuant to sections
12	92F-13 and 92F-19. If the legislature disagrees with the
13	attorney general's recommendation that all or a portion of the
14	settlement or judgment should be paid out of the general fund,
15	such funding shall be from the affected department's or
16	departments' operating budget. If the affected departments do
17	not have the funds to pay the settlement or judgment out of
18	their operating budgets, the legislature may appropriate funds
19	to satisfy the settlement or judgment out of the general fund
