A BILL FOR AN ACT

RELATING TO DENTAL ASSISTANTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the proper
2	standardization and regulation of dental assistants is necessary
3	to ensure the health, safety, and well-being of the State's
4	citizens. Currently, Hawaii is one of only a handful of states
5	that does not require dental assistants to be certified, and the
6	legislature finds that this exposes patients to unnecessary
7	risks. The legislature further finds that establishing minimum
8	requirements for dental assistants, including educational
9	requirements, will ensure that dental patients receive the best
10	available care.
11	Accordingly, the purpose of this Act is to establish
12	minimum requirements for dental assistants in Hawaii, including:
13	(1) Requiring an individual hired as a dental assistant on
14	or after July 1, 2021, to hold a cardiopulmonary
15	resuscitation certification and complete a two-
16	semester program accredited by the American Dental
17	Association Commission on Dental Accreditation:

1	(2)	Requiring all dental assistants employed as of July 1,
2		2020, to obtain a cardiopulmonary resuscitation
3		certification by July 1, 2021;
4	(3)	Requiring an individual employed as a dental assistant
5		for less than five years as of July 1, 2020, to
6		provide proof of enrollment in a two-semester program
7		accredited by the American Dental Association
8		Commission on Dental Accreditation;
9	(4)	Exempting an individual employed as a dental assistant
10		for at least five years as of July 1, 2020, from the
11		education requirements for dental assistants; provided
12		that the individual has no history of complaints filed
13		with the board of dentistry; and
14	(5)	Clarifying the allowable and prohibited practices of
15		dental assistants.
16	SECT	ION 2. Chapter 448, Hawaii Revised Statutes, is
17	amended by	y adding a new section to be appropriately designated
18	and to rea	ad as follows:
19	" <u>§44</u>	8- Dental assistants; requirements; allowed and
20	prohibite	d practices. (a) All individuals hired as dental
21	assistant	s in this State on or after July 1, 2021, shall:

1	<u>(1)</u>	Hold a cardiopulmonary resuscitation certification;
2		and
3	(2)	Provide proof to the board that the dental assistant
4		has successfully completed a two-semester program
5		accredited by the American Dental Association
6		Commission on Dental Accreditation.
7	(b)	An individual employed as a dental assistant as of
8	July 1, 2	020, shall obtain a cardiopulmonary resuscitation
9	certifica	tion by July 1, 2021.
10	<u>(c)</u>	An individual employed as a dental assistant for less
11	than five	years as of July 1, 2020, shall provide proof to the
12	board tha	t the individual has enrolled in a two-semester program
13	accredite	d by the American Dental Association Commission on
14	Dental Ac	creditation by July 1, 2021.
15	(d)	An individual employed as a dental assistant for at
16	least fiv	e years as of July 1, 2020, shall be exempt from the
17	education	requirement under subsection (a)(2); provided that the
18	individua	l has no history of complaints filed with the board.
19	<u>(e)</u>	A dental assistant may perform the following
20	supportiv	e dental procedures under the direct supervision,
21	direction	, evaluation, and responsibility of a licensed dentist:

1	(1)	Assi	sting a licensed dentist who is actually
2		perf	orming a dental procedure on a patient, including:
3		(A)	Preparing procedural trays or armamentaria set-
4			ups;
5		<u>(B)</u>	Retracting a patient's oral tissues to maintain
6			the field of operation during the dental
7			procedure;
8		<u>(C)</u>	Removing debris, as is normally created and
9			accumulated during or after operative procedures
10			by the dentist;
11		<u>(D)</u>	Placing and removing the rubber dam;
12		<u>(E)</u>	Mixing dental materials; and
13		<u>(F)</u>	Transferring dental instruments or any other
14			concept of four-handed dentistry the dentist
15			requires to perform the procedure;
16	(2)	Assi	sting a licensed dental hygienist in the
17		perf	ormance of the duties of the dental hygienist;
18		prov	ided that the assistance shall not include
19		proc	edures included in subsection (f);
20	(3)	Coll	ecting medical and dental histories, taking intra-
21		oral	and extra-oral photographs, and recording or

1		charting clinical findings as dictated by a licensed
2		dentist or dental hygienist;
3	(4)	Completing prescription and authorization forms for
4		drug or restorative, prosthodontic, or orthodontic
5		appliance for the supervising licensed dentist;
6		provided that the licensed dentist signs the forms;
7	(5)	Conducting mouth mirror supragingival inspections and
8		reporting observations to the supervising licensed
9		dentist; provided that the inspection and reporting
10		observations shall not be interpreted as an oral
11		<pre>cancer screening;</pre>
12	(6)	Exposing, processing, mounting, and labeling
13		radiographs;
14	(7)	Making impressions for study casts; opposing models;
15		occlusal appliances, such as splints and bite guards;
16		mouth guards; orthodontic retainers; and medicament
17		trays;
18	(8)	Making intra-oral measurements for orthodontic
19		procedures; performing the preliminary selection and
20		sizing of bands; checking for loose bands and bonded
21		brackets; placing and removing orthodontic separators,

1		ligature ties, and inter-arch elastics, including
2		chain elastics and rubber bands; fitting and removing
3		head appliances; and removing arch wires;
4	(9)	Measuring and recording vital signs;
5	(10)	Monitoring the nitrous oxide/oxygen unit and reporting
6		to the supervising dentist any adverse observations;
7		provided that the licensed dentist shall evaluate,
8		initiate, and administer the sedation;
9	(11)	Placing matrix retainers;
10	(12)	Placing non-aerosol topical anesthetics;
11	(13)	Relating pre-operative and post-operative instructions
12		and patient education in oral hygiene as instructed by
13		the supervising licensed dentist or licensed dental
14		hygienist;
15	(14)	Removing dressing and sutures;
16	(15)	Removing excess supragingival cement after a licensed
17		dentist has placed a permanent or temporary prosthetic
18		restoration, appliance, or orthodontic band with hand
19		instruments; and

1	(16)	Performing a try-in with any removable prosthetic or
2		orthodontic appliance; provided that the supervising
3		licensed dentist shall make the adjustments.
4	<u>(f)</u>	A dental assistant shall not perform any activity
5	deemed to	be irreversible so as to cause change in the affected
6	hard or s	oft tissues and is permanent, may require
7	reconstru	ctive or corrective procedures, or represents the
8	practice	of dentistry and dental hygiene or requires the
9	knowledge	, skill, and training of a licensed dentist or licensed
10	dental hy	gienist, including the following procedures and intra-
11	oral func	tions:
12	(1)	Administering local anesthetic, sedation, or general
13		anesthesia;
14	(2)	Cementing, bonding, and adjusting any part of a
15		prosthesis or appliance worn in the mouth;
16	(3)	Cementing or re-cementing, finishing margins,
17		performing a try-in, and adjusting the occlusion of a
18		temporary or permanent fixed prosthetic restoration,
19		or placing cement bases;
20	(4)	Cementing bands and brackets or activating any
21		orthodontic appliance;



1	(5)	Establishing occlusal vertical dimension, making bite
2		registrations, or making face-bow transfers;
3	(6)	Examining, diagnosing, or prescribing a treatment
4		plan;
5	(7)	Making final impressions, which would lead to the
6		fabrication of any appliance or prosthesis that, when
7		worn by the patient, would come in direct contact with
8		hard or soft tissues with the exception of the
9		procedures listed in subsection (e)(7);
10	(8)	Performing any endodontic procedure to ream, file,
11		irrigate, medicate, dry, try-in cores, or fill root
12		canals, or establishing the length of the tooth;
13	(9)	Performing any surgical or cutting procedures on hard
14		or soft tissues, extracting teeth, or suturing;
15	(10)	Placing, condensing, carving, finishing, or adjusting
16		the occlusion of final restorations; or placing cavity
17		liners, medicaments, or pulp cap materials;
18	(11)	Placings materials subgingivally including but not
19		limited to prescriptive medicaments, retraction cords,
20		and other devices that are used for tissue
21		displacement;

1	(12)	Prescribing medications or authorizing the fabrication
2		of any restorative, prosthodontic, or orthodontic
3		appliances;
4	(13)	Performing pulp vitality tests or other non-surgical
5		clinical and laboratory oral diagnostic tests;
6	(14)	Using ultrasonic instruments or polishing natural or
7		restored surfaces;
8	(15)	Applying pit and fissure sealants;
9	(16)	Performing non-surgical periodontal scaling and root
10		planing, and periodontal maintenance;
11	(17)	Performing dental prophylaxis, coronal polish natural
12		or restored surfaces, or removing overhangs;
13	(18)	Placing periodontal dressing;
14	(19)	Collecting, documenting, and assessing comprehensive
15		patient data including but not limited to screenings
16		for oral cancer, periodontal chartings, indices, and
17		risk assessments, which identify dental hygiene needs;
18	(20)	Establishing a dental hygiene care plan that reflects
19		dental hygiene goals and strategies; or
20	(21)	Providing dental hygiene care including but not
21		limited to pain management, full mouth debridement,

1	care of restorations, behavior modification, or
2	preventative education and nutrition counseling as it
3	relates to oral health."
4	SECTION 3. Section 448-3, Hawaii Revised Statutes, is
5	amended by amending subsection (b) to read as follows:
6	"(b) A duly licensed and registered dentist may employ
7	auxiliary personnel, other than registered dental hygienists, to
8	assist the dentist in the practice of dentistry. These
9	employees shall be known as dental assistants and shall perform
10	all duties assigned to them under the supervision, direction and
11	responsibility of the dentist[. Duties of the dental assistant
12	and regulatory directives shall be delineated under rules which
13	the board of dentistry may from time to time adopt.] pursuant to
14	section 488"
15	SECTION 4. Statutory material to be repealed is bracketed
16	and stricken. New statutory material is underscored.
17	SECTION 5. This Act shall take effect on July 1, 2020.
