A BILL FOR AN ACT

RELATING TO OFFSHORE DRILLING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the federal 2 government through the executive authority of the President has 3 proposed a program to vastly expand offshore drilling for oil or 4 natural gas. This program includes opening up Pacific ocean 5 waters near Alaska and the western coast of the continental 6 United States to potential offshore oil or natural gas drilling. 7 The legislature further finds that, although Hawaii has no 8 proven petroleum or natural gas reserves or production, the 9 State does produce petroleum products and crude oil is refined 10 within the State. The feedstock used to refine crude oil is 11 most often light sweet crude oil imported from producers in the

12 Pacific rim.

13 The legislature additionally finds that while petroleum 14 fired power plants supplied more than three-fourths of Hawaii's 15 utility-scale net electricity generation for most of the past 16 twenty years, the prominence of petroleum generated electricity 17 has declined recently. In 2014, for the first time, net

1	generation from petroleum was below seventy per cent. In 2016,
2	petroleum fueled two-thirds of the State's net generation.
3	The legislature also finds that the State is committed to
4	the promotion and development of renewable and sustainable
5	energy. Act 97, Session Laws of Hawaii 2015, established a goal
6	of one hundred per cent renewable energy in Hawaii by December
7	31, 2045.
8	The purpose of this Act is to prohibit:
9	(1) Offshore drilling for oil or natural gas in state
10	marine waters; and
11	(2) Issuance of permits for or in connection with the
12	development or operation of any facility or
13	infrastructure associated with offshore drilling for
14	oil or natural gas in state waters.
15	SECTION 2. Chapter 190D, Hawaii Revised Statutes, is
16	amended by adding a new section to be appropriately designated
17	and to read as follows:
18	" <u>§190D-</u> Offshore oil and gas exploration in state
19	waters; applications in support of oil and gas exploration;
20	prohibited. (a) Notwithstanding any law to the contrary,

1	offshore drilling for oil or natural gas shall be prohibited in
2	state marine waters.
3	(b) No permit shall be issued for or in connection with
4	the development or operation of any facility or infrastructure

7	SECTION 3. New statutory material is underscored.
8	SECTION 4. This Act shall take effect on December 31,
9	2050.
