## A BILL FOR AN ACT

RELATING TO SPORTS OFFICIALS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 707-700, Hawaii Revised Statutes, is
- 2 amended by adding three new definitions to be appropriately
- 3 inserted and to read as follows:
- 4 ""Lawful discharge of a sports official's duty" means the
- 5 performance of duties of a sports official from the time the
- 6 sports official arrives at the venue of a sports event and
- 7 ending when the sports official returns to their residence or
- 8 business.
- 9 "Sports event" means any organized amateur or professional
- 10 athletic contest in the State.
- 11 "Sports official" means a person at a sports event who
- 12 enforces the rules of the event, such as an umpire, referee,
- 13 timer, or scorer, or a person who supervises the participants,
- 14 such as a coach, regardless of whether the person is paid or
- 15 provides their services as an unpaid volunteer."

## Report Title:

Sports Officials; Assault; Terroristic Threatening

## Description:

Allows the court to enjoin a defendant from attending any sports event of the type at which the offense occurred for up to twelve months when convicted of certain assault or terroristic threatening and the victim of the offense is a sports official engaged in the lawful discharge of the sports officials' duties.
