### A BILL FOR AN ACT

RELATING TO HOME OWNERSHIP.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that approximately fifty-
- 2 seven per cent of Hawaii residents own their homes, which is one
- 3 of the lowest homeownership rates in the nation. Hawaii has
- 4 more obstacles than most states when it comes to purchasing a
- 5 property. Three state housing agencies, the Hawaii housing
- 6 finance and development corporation, the Hawaii public housing
- 7 authority, and the Hawaii community development authority, can
- 8 provide people with information and services for housing.
- 9 The legislature further finds that the Hawaii housing
- 10 finance and development corporation is tasked with developing
- 11 and financing low- and moderate-income housing projects and
- 12 administering homeownership programs. The Hawaii public housing
- 13 authority is charged with managing federal and state public
- 14 housing programs, including Section 8 and senior housing. The
- 15 Hawaii community development authority's function is to
- 16 establish community development plans in community development
- 17 districts, determine community development programs, and

- 1 cooperate with private enterprise and the various components of
- 2 federal, state, and county governments to bring community
- 3 development plans to fruition. These three agencies are located
- 4 in different areas on Oahu.
- 5 The legislature finds that in order to allow these agencies
- 6 to better collaborate and work to more effectively and
- 7 efficiently provide housing information and services to the
- 8 people of Hawaii, the three agencies' offices should be located
- 9 in one shared facility.
- 10 The purpose of this Act is to relocate the Hawaii housing
- 11 finance and development corporation, the Hawaii public housing
- 12 authority, and the Hawaii community development authority to one
- 13 shared facility and make appropriations to assist those agencies
- 14 in their relocation.
- 15 SECTION 2. The Hawaii housing and development corporation,
- 16 the Hawaii public housing authority, and the Hawaii community
- 17 development authority shall be relocated to one shared existing
- 18 facility to be mutually determined by those agencies. The
- 19 relocation shall be conducted in phases and shall be completed
- 20 by July 1, 2022.

- 1 SECTION 3. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$ or so
- 3 much thereof as may be necessary for fiscal year 2020-2021 to
- 4 assist the Hawaii housing finance and development corporation in
- 5 relocating from its current location to the shared facility as
- 6 required by section 2 of this Act.
- 7 The sum appropriated shall be expended by the Hawaii
- 8 housing finance and development corporation for the purposes of
- 9 this Act.
- 10 SECTION 4. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$ or so
- 12 much thereof as may be necessary for fiscal year 2020-2021 to
- 13 assist the Hawaii public housing authority in relocating from
- 14 its current location to the shared facility as required by
- 15 section 2 of this Act.
- The sum appropriated shall be expended by the Hawaii public
- 17 housing authority for the purposes of this Act.
- 18 SECTION 5. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of \$ or so
- 20 much thereof as may be necessary for fiscal year 2020-2021 to
- 21 assist the Hawaii community development authority in relocating

- 1 from its current location to the shared facility as required by
- 2 section 2 of this Act.
- 3 The sum appropriated shall be expended by the Hawaii
- 4 community development authority for the purposes of this Act.
- 5 SECTION 6. This Act shall take effect on July 1, 2020.
