A BILL FOR AN ACT

RELATING TO MINIMUM WAGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 387, Hawaii Revised Statutes, is									
2	amended by adding a new section to be appropriately designated									
3	and to read as follows:									
4	"§387- Minimum wage commission. (a) There is									
5	established within the department of labor and industrial									
6	relations a minimum wage commission, for administrative purposes									
7	only. Members of the committee shall include, but are not									
8	limited to, the following:									
9	(1) The director of labor and industrial relations or the									
10	director's designee;									
11	(2) The director of human services or the director's									
12	designee;									
13	(3) Two members appointed by the governor;									
14	(4) Two members appointed by the president of the senate;									
15	(5) Two members appointed by the speaker of the house of									
16	representatives; and

1	(6) Three other representatives from other organizations									
2	that may assist in providing necessary expertise.									
3	(b) Vacancies in these positions shall be filed in the									
4	same manner. The members of the commission shall serve without									
5	compensation but may be reimbursed for expenses; including									
6	travel expenses, incurred in the discharge of their duties.									
7	(c) The commission shall review and recommend an									
8	appropriate minimum wage.									
9	(d) Before the twentieth legislative day of the regular									
10	session of 2020 and every year thereafter, the commission shall									
11	study and make recommendations for any increase in the minimum									
12	wage and the recommended effective date of the increase,									
13	provided that the recommended effective date shall be no earlier									
14	than the adjournment of the legislative session following the									
15	committees recommendation. A recommended increase by the									
16	commission shall be effective as of the date set forth in the									
17	recommendation unless the legislature disapproves the									
18	recommendation by adoption of a concurrent resolution prior to									
19	adjournment sine die of the legislative session in which the									
20	recommendation is submitted."
