A BILL FOR AN ACT

RELATING TO THE DEPOSIT BEVERAGE CONTAINER FEE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 342G-102, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§342G-102 Deposit beverage container fee. (a) Beginning
- 4 on October 1, 2002, every deposit beverage distributor shall pay
- 5 to the department a deposit beverage container fee on each
- 6 polyethylene terephthalate, high density polyethylene, or metal
- 7 deposit beverage container manufactured in or imported into the
- 8 State. The fee shall be imposed only once on the same deposit
- 9 beverage container. The fee shall be 0.5 cents per deposit
- 10 beverage container.
- 11 (b) Beginning on October 1, 2004, every deposit beverage
- 12 distributor shall pay to the department a deposit beverage
- 13 container fee on each deposit beverage container manufactured in
- 14 or imported into the State. The deposit beverage container fee
- 15 shall not apply to deposit beverage containers exported for sale
- 16 outside of the State. The fee shall be imposed only once on the

- 1 same deposit beverage container. The fee shall be 1 cent per
- 2 deposit beverage container.
- 3 (c) No county shall impose or collect any assessment or
- 4 fee on deposit beverage containers for the same or similar
- 5 purpose that is the subject of this chapter.
- 6 (d) Beginning January 1, 2005, and every August 1
- 7 thereafter, the department shall notify deposit beverage
- 8 distributors in writing of the amount of the deposit beverage
- 9 container fee. The effective date of changes to the fee amount
- 10 shall be September 1. The fee shall be based on the redemption
- 11 rate calculated annually based on the redemption rate
- 12 information submitted to the department for the previous period
- 13 of July 1 through June 30. The fee amount shall be as follows:
- 14 (1) If the redemption rate is seventy per cent or less: 1
- cent per container; and
- 16 (2) If the redemption rate is greater than seventy per
- 17 cent: 1.5 cents per container.
- (e) Beginning on August 1, 2021, and every August 1
- 19 thereafter, the deposit beverage container fee shall be changed
- 20 by the percentage, if any, by which the Consumer Price Index for
- 21 All Urban Consumers in the Honolulu area published by the Bureau

- 1 of Labor Statistics of the federal Department of Labor for that
- 2 calendar year exceeds the Consumer Price Index for All Urban
- 3 Consumers for the prior calendar year.
- 4 [(e)] (f) The director may temporarily suspend an
- 5 automatic increase of the deposit beverage container fee if,
- 6 after consultation with the auditor, it is determined that the
- 7 deposit beverage container deposit special fund contains
- 8 sufficient funds for the purposes of section 342G-104(b)."
- 9 SECTION 2. Statutory material to be repealed is bracketed
- 10 and stricken. New statutory material is underscored.
- 11 SECTION 3. This Act shall take effect upon its approval.
