A BILL FOR AN ACT

RELATING TO PUEO RESEARCH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the pueo, or 2 Hawaiian short-eared owl, is an endemic subspecies of short-3 eared owl, commonly referred to as the "bird of wisdom" and 4 believed to offer guidance and protection. The pueo has a 5 special place in Hawaii's culture and was revered by many 6 ancient Hawaiian families as an 'aumakua, or ancestral guardian. As the only native raptors found in Hawaii, the pueo plays an 7 8 important and unique role in the State's ecosystem. Based on 9 the cultural significance and potential ecological benefits of 10 the pueo in the State, it is important to evaluate the species' 11 conservation status.

12 The legislature recognizes that pueo on Oahu are currently 13 protected as "endangered" under state law due to their low 14 population numbers. However, a comprehensive assessment of pueo 15 populations on all of the main Hawaiian islands has never been 16 conducted.
