### A BILL FOR AN ACT

RELATING TO UNDERGROUND STORAGE TANKS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that action is needed to
- 2 protect Hawaii's groundwater from contamination. Large capacity
- 3 underground storage tank systems pose a threat to the potability
- 4 of the State's groundwater.
- 5 The purpose of this Act is to prohibit the operation of
- 6 large capacity underground storage tank systems mauka of the
- 7 underground injection control line, beginning January 1, 2028.
- 8 SECTION 2. Chapter 342L, Hawaii Revised Statutes, is
- 9 amended by adding a new section to be appropriately designated
- 10 and to read as follows:
- 11 "§342L- Underground storage tank system; underground
- 12 injection control line; prohibition. Beginning January 1, 2028,
- 13 no person shall operate an underground storage tank system that
- has a capacity of 100,000 gallons or more, mauka of the
- 15 underground injection control line.
