A BILL FOR AN ACT

RELATING TO ELECTRIC FOOT SCOOTERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 291C, Hawaii Revised Statutes, is
- 2 amended by adding a new section to part XII to be appropriately
- 3 designated and to read as follows:
- 4 "§291C- Electric foot scooters. (a) This section
- 5 shall apply whenever an electric foot scooter is operated upon
- 6 any highway, roadway, or other designated public area set aside
- 7 for the use of electric foot scooters. Every person operating
- 8 an electric foot scooter upon a roadway shall be granted all of
- 9 the rights and shall be subject to all of the duties applicable
- 10 to a driver of a vehicle under this chapter, except as to
- 11 provisions of this:
- (1) Section to the contrary; and
- 13 (2) Chapter that, by their nature, can have no
- application.
- 15 (b) The counties by ordinance shall regulate operations of
- 16 electric foot scooters with regard to, but not limited to, the
- 17 following:

| 11 | other public property in the State. No person under sixteen |
| 12 | years of age shall operate an electric foot scooter unless the |
| 13 | person wears a safety helmet securely fastened with a chin |
| 14 | strap. The safety helmet shall meet the specifications of and |
| 15 | requirements for a bicycle helmet as set out in section |
| 16 | 291C-150. |
| 17 | (d) No person shall operate an electric foot scooter that |
| 18 | is carrying any other person, nor shall any person other than |
| 19 | the operator ride upon an electric foot scooter. |
| 20 | (e) No person operating an electric foot scooter shall |
| 21 | carry any package, bundle, or article that prevents the use of |

1 both hands in the control and operation of the electric foot 2 scooter. 3 (f) Any electric foot scooter used from thirty minutes 4 after sunset until thirty minutes before sunrise shall be 5 equipped as provided in section 291C-147; provided that in lieu 6 of the requirement of section 291C-147(b), every electric foot 7 scooter shall be equipped with a lighted lamp that is visible 8 from the rear. 9 (g) No person shall operate an electric foot scooter at a 10 speed other than is reasonable and prudent and having regard to 11 the actual and potential hazards and conditions then existing; 12 provided that no person shall operate an electric foot scooter 13 at a speed greater than fifteen miles per hour. 14 (h) Any person who operates an electric foot scooter 15 recklessly in disregard of the safety of persons or property 16 shall be assessed penalties as set forth in section 291C-161. 17 (i) A person or entity that provides electric foot scooters for hire shall not rent or lease an electric foot 18

scooter to any person unless:

| 16 | seventy-five pounds, with two or three wheels, handlebars, and a |
| 17 | floorboard that can be stood upon while riding, that is solely |

| 19 | speed, with or without human propulsion on a paved level |
| 20 | surface, does not exceed fifteen miles per hour." |

- 16 amended as follows:

- 12 bicycle, electric foot scooter, or moped upon a bicycle lane or
- 13 bicycle path, except upon a permanent or authorized temporary
- 14 driveway, or park any vehicle upon a bicycle lane or bicycle
- 15 path; provided that any vehicle may be driven or parked in a
- 16 bicycle lane or bicycle path as applicable if:
- 17 (1) It is in the process of executing a legal turn, lane
- change, or parking maneuver;
- 19 (2) It is an authorized emergency vehicle performing the
- functions under section 291C-26;

Electric Foot Scooters; Regulation

Description:

Establishes a framework for the regulation of electric foot scooters by the State and counties. Amends definitions of "moped" to exclude electric foot scooters.
