A BILL FOR AN ACT

RELATING TO ADDRESS CONFIDENTIALITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that on July 5, 2018,
- 2 Governor David Y. Ige signed into law Act 115, Session Laws of
- 3 Hawaii 2018, known as the Address Confidentiality Act. This law
- 4 provides survivors of domestic abuse, sexual offenses, or
- 5 stalking with a substitute address to be used by state and local
- 6 government agencies instead of their physical address. The
- 7 substitute address may be used whenever an address is required
- 8 for public records. Mail is received at the substitute address
- 9 and forwarded to the survivor's actual address.
- 10 The legislature also finds that no moneys were allocated to
- 11 support the program, and without additional funding, the office
- 12 of the lieutenant governor's current budget is unable to absorb
- 13 the start-up and day-to-day operational cost of maintaining the
- 14 program. Currently, the office of the lieutenant governor is
- 15 preparing to implement the program, but unless necessary funding
- 16 is available, the office of the lieutenant governor will be
- 17 unable to carry out the program's objectives.
