### A BILL FOR AN ACT

RELATING TO INFORMATION TECHNOLOGY STEERING COMMITTEE.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds it to be in the best
- 2 interest of the public to allow the members of the information
- 3 technology steering committee to serve without regard to term
- 4 limits because their institutional knowledge of the State's
- 5 complex information systems would assist the chief information
- 6 officer in developing the State's information technology
- 7 standards and policies. In addition, the legislature finds it
- 8 to be in the best interest of the public for the superintendent
- 9 of education and the president of the University of Hawaii to
- 10 appoint representatives to the committee.
- 11 SECTION 2. Section 27-43, Hawaii Revised Statutes, is
- 12 amended by amending subsection (b) to read as follows:
- "(b) There is established an information
- 14 technology steering committee to assist the chief information
- 15 officer in developing the State's information technology
- 16 standards and policies, including but not limited to:
- 17 (1) Assisting the chief information officer in

1		developing and implementing the state information
2		technology strategic plans;
3	(2)	Assessing executive branch departments' progress in
4		meeting the objectives defined in the state
5		information technology strategic plans and identifying
6		best practices for shared or consolidated services;
7	(3)	Ensuring technology projects are selected based on
8		their potential impact and risk to the State, as well
9		as their strategic value;
10	(4)	Ensuring that executive branch departments maintain
11		sufficient tools to assess the value and benefits of
12		technology initiatives;
13	(5)	Assisting the chief information officer in developing
14		state information technology standards and policies;
15		and
16	(6)	Clarifying the roles, responsibilities, and authority
17		of the office of enterprise technology services,
18		specifically as it relates to its statewide duties.
19	The i	information technology steering committee shall consist
20	of eleven	members[7] appointed for four-year terms, without
21	regard to	section 26-34, with [four] three members to be
22	appointed	by the senate president, [four] three members to be
23	appointed	by the speaker of the house of representatives, one

- 1 member to be appointed by the chief justice, [and] one member to
- 2 be appointed by the governor, one member to be appointed by the
- 3 superintendent of education, and one member to be appointed by
- 4 the president of the University of Hawaii, and [shall] may
- 5 include representatives from executive branch departments[,
- 6 including large user agencies such as the department of
- 7 education and the University of Hawaii; the judiciary]; the
- 8 legislature; and private individuals. The chief information
- 9 officer shall serve as an ex officio member of the committee and
- 10 as the chair of the committee [and shall ensure that the
- 11 committee is evaluated periodically]. Each member shall hold
- 12 office until the member's successor is appointed. Because
- 13 cumulative experience and continuity in office are essential to
- 14 the proper administration of this part, it is declared to be in
- 15 the public interest to continue members in office as long as
- 16 efficiency is demonstrated."
- SECTION 3. The president of the senate and the speaker of
- 18 the house of representatives shall each remove one member they
- 19 appointed to the committee. The superintendent of education and
- 20 the president of the University of Hawaii shall each appoint a
- 21 member to the committee.
- SECTION 4. Statutory material to be repealed is bracketed
- 23 and stricken. New statutory material is underscored.
