| | BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII: |

| Ĺ | SECTION 1. The purpose of this Act is to amend the |
| 2 | procurement laws relating to the purchase of health and human |
| 3 | services to promote procurement efficiency, program success, and |
| 4 | government accountability by: |
| 5 | (1) Authorizing the procurement policy board to adopt |
| 6 | administrative rules to provide an expedited method |
| 7 | for purchasing agencies to competitively procure |
| 8 | health and human services small purchases; |
| 9 | (2) Increasing efficiency and short-term treatment |

- (2) Increasing efficiency and short-term treatment purchase of services;
- (3) Promoting fair and reasonable prices through government transparency and accountability; and
- (4) Streamlining membership requirements for theprocurement policy board.
- 15 SECTION 2. Chapter 103F, Hawaii Revised Statutes, is
 16 amended by adding to part IV a new section to be appropriately
 17 designated and to read as follows:

| 8 | action is fair and reasonable, the procuring agency shall obtain |
| 9 | the data necessary to perform a cost or price analysis to |
| 10 | determine that the amount of the contracting action is a fair |
| 11 | and reasonable price." |
| 12 | SECTION 3. Section 103D-201, Hawaii Revised Statutes, is |
| 13 | amended by amending subsection (b) to read as follows: |
| 14 | "(b) The policy board shall consist of $[seven]$ six |
| 15 | members. Notwithstanding the limitations of section 78-4, the |
| 16 | members of the board shall include: |
| 17 | (1) The comptroller; |
| 18 | (2) A county employee with significant high-level |
| 19 | procurement experience; and |
| 20 | (3) [Five] Four persons who shall not otherwise be full- |
| 21 | time employees of the State or any county; provided |

| 1 | that at least one member shall be a [certified] |

| 2 | professional in the field of procurement, at least one |
| 3 | member shall have significant high-level, federal |
| 4 | procurement experience, and at least [two members] one |
| 5 | member shall have significant experience in the field |

| 7 | Each appointed member shall have demonstrated sufficient |
| 8 | business or professional experience to discharge the functions |
| 9 | of the policy board. The initial and subsequent members of the |
| 10 | policy board, other than the comptroller, shall be appointed by |
| 11 | the governor from a list of $[\frac{\text{three}}{\text{two}}]$ individuals for each |
| 12 | vacant position, submitted by a nominating committee composed of |
| 13 | [four] three individuals chosen as follows: [two persons] one |
| 14 | person appointed by the governor; one person appointed by the |
| 15 | president of the senate; and one person appointed by the speaker |
| 16 | of the house. Except as provided in this section, the selection |
| 17 | and terms of the policy board members shall be subject to the |
| 18 | requirements of section 26-34. No member of the policy board |
| 19 | shall act concurrently as a chief procurement officer. The |
| 20 | members of the policy board shall devote such time to their |
| 21 | duties as may be necessary for the proper discharge thereof." |

| 7 | (b) [At a minimum, before the beginning of each fiscal |
| 8 | year, the administrator shall publish a notice describing the |
| 9 | types of treatment services that may be needed throughout the |
| 10 | year on a periodic basis and inviting providers engaged in |
| 11 | providing these treatment services to submit current statements |
| 12 | of qualification and expressions of interest to the office. The |
| 13 | chief procurement officer may specify a uniform format for |
| 14 | statements of qualifications. The head of the purchasing |
| 15 | agency, or a designee, shall, at a minimum, publish a notice |
| 16 | describing the types of treatment services that may be needed |
| 17 | throughout the fiscal year on an as-needed basis and inviting |
| 18 | providers engaged in providing these treatment services to |
| 19 | submit current statements of qualification and expressions of |
| 20 | interest to the purchasing agency. Providers may amend these |

- 1 statements by filing an amended or new statement prior to the
- 2 date designated for submission.
- 3 (c) The [administrator] head of the purchasing, or a
- 4 designee, shall form an initial review committee for each
- 5 profession, consisting of a minimum of three employees from a
- 6 state agency or agencies with sufficient education, training,
- 7 and licenses or credentials to evaluate the statements of
- 8 qualifications which the [administrator] head of the purchasing
- 9 agency, or a designee, receives in response to the notice
- 10 published pursuant to subsection (b). The committee shall
- 11 review and evaluate the submissions and other pertinent
- 12 information, including references and reports, and prepare a
- 13 list of qualified providers to provide treatment services during
- 14 the fiscal year. Providers included on the list of qualified
- 15 treatment providers may amend their statements of qualifications
- 16 as necessary or appropriate. Providers shall immediately inform
- 17 the [administrator] head of the purchasing agency of any changes
- 18 in information furnished [which] that would disqualify the
- 19 provider from being considered for a contract award.
- 20 (d) When the need to purchase treatment arises, the head
- 21 of a purchasing agency shall select the provider most qualified

- 1 to provide the needed treatment from the list of qualified
- 2 providers.
- 3 (e) The head of the purchasing agency, or a designee,
- 4 shall negotiate a contract, including a rate of compensation
- 5 [which] that is fair and reasonable, established in writing, and
- 6 based upon the estimated value, scope, nature, and complexity of
- 7 the treatment services to be rendered, or use the rate
- 8 established by the [administrator,] head of the purchasing
- 9 agency, or a designee, if any. If negotiations fail, upon
- 10 written notice of an impasse to the provider selected under
- 11 subsection (d), the head of the purchasing agency shall choose
- 12 another provider from the list of qualified providers, and
- 13 conduct further negotiations. Negotiations shall be conducted
- 14 confidentially.
- (f) Contracts for treatment services in excess of \$100,000
- 16 or that last for more than one year shall [be procured using
- 17 section 103F 402, competitive purchase of services, unless a
- 18 waiver of this subsection is approved by the chief procurement
- 19 officer.] utilize an alternative applicable method of
- 20 procurement."

- 1 SECTION 5. Section 103F-405, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "[+] §103F-405[+] Small purchases. Purchases of health and
- 4 human services of less than [\$25,000] \$100,000 are small
- 5 purchases, and shall be made in accordance with [section 103D-
- 6 305 and] rules adopted by the policy board to implement [that]
- 7 this section."
- 8 SECTION 6. Statutory material to be repealed is bracketed
- 9 and stricken. New statutory material is underscored.
- 10 SECTION 7. This Act shall take effect upon its approval.

Report Title:

Procurement; Price or Cost Data; Procurement Policy Board; Treatment Purchase of Services; Small Purchase of Service

Description:

Requires cost or pricing analysis for health and human services purchasing. Changes membership of the Procurement Policy Board. Authorizes purchasing agency heads, or their designees, to issue requests for statement of qualifications and to establish lists of qualified providers for treatment purchase of services. Increases the small purchase threshold for health and human services. (SD1)
