JUSTIFICATION SHEET

DEPARTMENT: Commerce and Consumer Affairs

TITLE: A BILL FOR AN ACT RELATING TO CEMETERY AUTHORITY EXEMPTION.

PURPOSE: To clarify that churches granted an exemption under section 441-22.1, Hawaii Revised Statutes (HRS), are exempt from all requirements of chapter 441, HRS, and that other exempted entities shall comply with any provision of this chapter upon order of the director of the Department of Commerce and Consumer Affairs.

MEANS: Amend section 441-22.1, HRS.

JUSTIFICATION: In 1967, legislation was enacted to regulate cemeteries, which created monetary difficulties for certain nonprofit cemeteries that were not actively engaged in the business of selling cemetery property. Act 14, Session Laws of Hawaii 1968, authorized the then-Cemetery Board to exempt any cemetery authority from the bonding and fee requirements for license, renewal, and reinstatement if it did not actively engage in pre-need sales, have a licensed cemetery salesperson, or sell for financial profit.

> Since 1968, exempt cemetery authorities have not been regulated and have been treated as exempt from the requirements of chapter 441, HRS. The Cemetery and Funeral Trusts Program seeks to codify its current practice by exempting churches granted an exemption under section 441-22.1 from the requirements of chapter 441.
