A BILL FOR AN ACT

RELATING TO REPORTS OF CHILD ABUSE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The Child Abuse Prevention and Treatment Act,
- 2 as amended, provides federal funding to states for prevention,
- 3 assessment, investigation, prosecution, and treatment activities
- 4 for child abuse and neglect. On January 7, 2019, the Victims of
- 5 Child Abuse Act Reauthorization Act of 2018 (P.L. 115-424), was
- 6 enacted, further amending certain provisions of Child Abuse
- 7 Prevention and Treatment Act. The 2019 amendment provides
- 8 immunity from civil and criminal liability "for individuals
- 9 making good faith reports of suspected or known instances of
- 10 child abuse or neglect, or who otherwise provide information or
- 11 assistance, including medical evaluations or consultations, in
- 12 connection with a report, investigation, or legal intervention
- 13 pursuant to a good faith report of child abuse or neglect." 42
- 14 USCA §5106a(b)(2)(B)(vii).
- 15 The purpose of this Act is to bring state law into
- 16 compliance with the most recent amendments to Child Abuse

- 1 Prevention and Treatment Act by amending section 350-3(a),
- 2 Hawaii Revised Statutes by no later than June 30, 2020.
- 3 SECTION 2. Section 350-3, Hawaii Revised Statutes, is
- 4 amended by amending subsection (a) to read as follows:
- 5 "(a) Anyone participating in good faith in the making of a
- 6 report pursuant to this chapter shall have immunity from any
- 7 liability, civil or criminal, that might be otherwise incurred
- 8 or imposed by or as a result of the making of such report [-] and
- 9 this immunity shall also apply to persons who otherwise provide
- 10 information or assistance, including medical evaluations or
- 11 consultation, in connection with a report, investigation, or
- 12 legal intervention pursuant to a good faith report of child
- 13 abuse or neglect. Any such participant shall have the same
- 14 immunity with respect to participation in any judicial
- 15 proceeding resulting from such report."
- 16 SECTION 3. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.
- 18 SECTION 4. This Act shall take effect June 30, 2020.
