A BILL FOR AN ACT

RELATING TO THE SUPPLEMENTAL BUDGET.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 Unless otherwise clear from the context, as
- 2 used in this Act:
- 3 "Appropriations" as described in this Act are supplemental
- 4 appropriation for fiscal year 2020-2021.
- 5 "Expending agency" means the executive department,
- 6 independent commission, bureau, office, board, or other
- 7 establishment of the state government (other than the
- 8 legislature, Office of Hawaiian Affairs, and judiciary), the
- 9 political subdivisions of the State, or any quasi-public
- 10 institution supported in whole or in part by state funds, which
- 11 is authorized to expend specified appropriations made by this
- 12 Act.
- 13 For purposes of this Act, the expending agency is the
- 14 department of business, economic development, and tourism and
- 15 referred to in this Act by its abbreviation as "BED".
- 16 "Item No." refers to the program listed in numerical order
- 17 in this Act.

1 "Means of financing" or "MOF" means the source from which 2 funds are appropriated or authorized to be expended for the 3 programs and projects specified in this Act. All appropriations 4 are followed by letter symbols. The following sums, or so much thereof as may 14 SECTION 2. 15 be sufficient to accomplish the purposes and programs designated 16 in this Act are hereby appropriated or authorized, as the case 17 may be, from the means of financing specified to the expending 18 agencies designated for the fiscal biennium beginning July 1, 19 2019, and ending June 30, 2021. The total expenditures and the 20 number of positions in each fiscal year of the biennium shall

not exceed the sums and the position ceilings indicated for each
