A BILL FOR AN ACT

RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 206E-3, Hawaii Revised Statutes, is 2 amended by amending subsection (b) to read as follows: 3 "(b) The authority shall consist of the director of 4 finance or the director's designee; the director of 5 transportation or the director's designee; a cultural 6 specialist; an at-large member; an at-large member nominated by 7 the [senate] president[;] of the senate; an at-large member 8 nominated by the speaker of the house [+] of representatives; 9 three representatives of the Heeia community development 10 district, comprising two residents of that district or the 11 Koolaupoko district, which consists of sections 1 through 9 of 12 zone 4 of the first tax map key division, and one owner of a 13 small business or one officer or director of a nonprofit 14 organization in the Heeia community development district or 15 Koolaupoko district, with one each nominated by the [county 16 council of the county in which the Heeia community development 17 district is located;] governor, president of the senate, and

1 speaker of the house of representatives; three representatives 2 of the Kalaeloa community development district, comprising two 3 residents of the Ewa zone (zone 9, sections 1 through 2) or the 4 Waianae zone (zone 8, sections 1 through 9) of the first tax map 5 key division, and one owner of a small business or one officer 6 or director of a nonprofit organization in the Ewa or Waianae 7 zone, with one each nominated by the [county council of-the 8 county in which the Kalaeloa community development district is 9 located;] governor, president of the senate, and speaker of the 10 house of representatives; three representatives of the Kakaako 11 community development district, comprising two residents of the 12 district and one owner of a small business or one officer or 13 director of a nonprofit organization in the district, nominated 14 by the [county council of the county in which the Kakaako 15 community development district is located;] governor, president 16 of the senate, and speaker of the house of representatives; the 17 director of planning and permitting of each county in which a community development district is located or the director's 18 19 designee, who shall serve in an ex officio, nonvoting capacity; 20 and the chairperson of the Hawaiian homes commission or the

chairperson's designee, who shall serve in an ex officio,
 nonvoting capacity.

3 All members except the director of finance, director of 4 transportation, county directors of planning and permitting, and 5 chairperson of the Hawaiian homes commission or their designees 6 shall be appointed by the governor pursuant to section 26-34. 7 The two at-large members nominated by the [senate] president of 8 the senate and speaker of the house of representatives and the 9 nine representatives of the respective community development 10 districts shall each be appointed by the governor from a list of 11 three nominees submitted for each position by the nominating 12 authority specified in this subsection.

13 The authority shall be organized and shall exercise14 jurisdiction as follows:

15 (1) For matters affecting the Heeia community development

provided that the director of planning and permitting of the relevant county or the director's designee shall participate in these matters as an ex officio, nonvoting member and shall not be considered in determining quorum and majority.

6 In the event of a vacancy, a member shall be appointed to 7 fill the vacancy in the same manner as the original appointment 8 within thirty days of the vacancy or within ten days of the 9 senate's rejection of a previous appointment, as applicable.

10 The terms of the director of finance, director of 11 transportation, county directors of planning and permitting, and 12 chairperson of the Hawaiian homes commission or their respective 13 designees shall run concurrently with each official's term of 14 office. The terms of the appointed voting members shall be for 15 four years, commencing on July 1 and expiring on June 30; 16 provided that the initial terms of all voting members initially appointed pursuant to Act 61, Session Laws of Hawaii 2014, shall 17 18 commence on March 1, 2015. The governor shall provide for 19 staggered terms of the initially appointed voting members so 20 that the initial terms of four members selected by lot shall be 21 for two years, the initial terms of four members selected by lot

shall be for three years, and the initial terms of the remaining
 five members shall be for four years.

3 The governor may remove or suspend for cause any member4 after due notice and public hearing.

5 Notwithstanding section 92-15, a majority of all eligible 6 voting members as specified in this subsection shall constitute 7 a quorum to do business, and the concurrence of a majority of 8 all eligible voting members as specified in this subsection 9 shall be necessary to make any action of the authority valid. 10 All members shall continue in office until their respective 11 successors have been appointed and qualified. Except as herein 12 provided, no member appointed under this subsection shall be an 13 officer or employee of the State or its political subdivisions.

14 For purposes of this section, "small business" means a 15 business which is independently owned and which is not dominant 16 in its field of operation."

17 SECTION 2. Statutory material to be repealed is bracketed18 and stricken. New statutory material is underscored.

SECTION 3. This Act shall take effect upon its approval;
provided that the existing representatives of the Heeia
community development district, Kalaeloa community development
