### A BILL FOR AN ACT

SECTION 1. Section 109-1, Hawaii Revised Statutes, is

RELATING TO THE STADIUM AUTHORITY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 2 amended by amending subsections (a) and (b) to read as follows: 3 "(a) There shall be within the department of accounting 4 and general services for administrative purposes only, a stadium 5 authority whose responsibility shall be to maintain, operate, 6 and manage the stadium and facilities attached thereto. The 7 authority shall consist of [nine] eleven members who shall be 8 appointed by the governor in the manner prescribed by section 9 26-34. Each member of the authority shall have been a citizen 10 of the United States and a resident of the State for at least 11 five years next preceding the member's appointment [-]; provided
- 13 (1) One member is a resident of Aiea or Halawa; and
- 14 (2) One member is a resident of Foster Village,
- 15 Crosspointe, or Alii Plantation.

- 1 The president of the University of Hawaii and the superintendent
- 2 of education shall be ex officio members of the authority but
- 3 shall not vote.
- 4 (b) The chairperson of the authority shall be elected by
- 5 the majority of the authority. The term of each member shall be
