A BILL FOR AN ACT

RELATING TO ECONOMIC DEVELOPMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 The legislature finds that continued
- 2 advancement of technology with the growth of automation and
- artificial intelligence is poised to fundamentally reshape our 3
- 4 local and global economy. Some reports predict that automation
- 5 may eliminate one-third of the nation's jobs by 2030, and that
- as high as forty-five per cent of current business tasks could 6
- potentially be automated. As such, rising generations will be 7
- required to possess the skills and adaptability to thrive in 8
- 9 this new economy. Projections show that approximately sixty-
- 10 five per cent of students in school will hold jobs that do not
- 11 exist yet.
- 12 The legislature further finds that although Hawaii has one
- **13** of the lowest unemployment rates in the nation, many existing
- 14 jobs are lower wage jobs in the visitor industry. Moreover,
- 15 high housing costs and the high cost of living are outpacing



- 1 wages. In addition, there are not enough job opportunities in
- 2 the State for high-wage, skilled workers. Consequently, the
- 3 United States Census Bureau recently found that there are
- 4 thirty-seven more people per day who are moving out of Hawaii
- 5 than are moving into the State.
- 6 Given this looming challenge, the legislature finds that
- 7 the State must develop a strategic, forward-looking approach
- 8 toward work-based learning to better prepare students for
- 9 college and their careers. Accordingly, the department of
- 10 business, economic development, and tourism should be required
- 11 to develop annual regional economic plans for each county based
- 12 on the boundaries of development or community plans in each
- 13 county. The workforce development council, in partnership with
- 14 the department of education and the University of Hawaii, can
- 15 use this data to provide K-16 pathways and internship programs
- 16 in each public and public charter school to match the State's
- 17 specific industry needs. These pathways and qualified
- 18 internship programs will serve as the foundation for developing
- 19 work-based learning opportunities in public schools that reflect

- 1 high-growth, high-need industries, which are often concentrated
- 2 in healthcare, technical roles, business and finance,
- 3 information technology, and management.
- 4 Furthermore, the legislature finds that schools and
- 5 industry partners should be empowered to offer qualified student
- 6 internship programs. Therefore, qualified internship programs
- 7 should be exempted from the procurement process.
- 8 Accordingly, the purpose of this Act is to:
- 9 (1) Require the department of business, economic
- development, and tourism to develop annual regional
- economic plans for each county based on the boundaries
- of the development or community plans in each county;
- 13 (2) Exempt qualified internship programs from the
- 14 procurement process; and
- 15 (3) Appropriate funds.
- 16 SECTION 2. Chapter 201, Hawaii Revised Statutes, is
- 17 amended by adding a new section to be appropriately designated
- 18 and to read as follows:
- 19 "§201- Regional economic plans. (a) The department of
- 20 business, economic development, and tourism shall develop annual



1	regional	economic plans to provide jobs in urban and rural areas
2	in each c	county based on the development or community boundaries
3	of each r	respective county.
4	(b)	These plans shall be published by January 31 annually
5	on the de	partment's website and include a list of regional
6	economic	priorities and industry clusters, and jobs within these
7	prioritie	s and industry clusters.
8 .	(c)	Based on the findings of these regional economic
9	plans, th	e workforce development council shall consult the
10	departmen	t of education and the University of Hawaii to develop
11	and provi	de K-12 pathways and programs in each public school
12	that:	
13	(1)	Emphasize the skills necessary to meet the State's
14		specific industry needs;
15	(2)	Relate to employment in jobs identified by the
16		department as priority jobs, concentrated in
17		healthcare, technical roles, business and finance,
18		information technology, and management; and

1	(3) Result in a degree or credential that meets entry-
2	level requirements of employers in relevant priority
3	industries.
4	(d) The priority jobs identified shall be in high-demand,
5	high-growth positions that provide a living wage for an average
6	family of three persons with one working adult.
7	(e) "Qualified internship programs" means programs that
8	prepare students for jobs that are identified by regional
9	economic plans as a priority in the geographical area.
10	(f) Schools shall communicate opportunities to enroll in
11	these pathways or qualified internship programs to students and
12	parents.
13	(g) For budget year 2019-2020 and each budget year
14	thereafter, each participating public school and public charter
15	school may receive up to \$1,000 in bonus incentives for each
16	student who has successfully completed a qualified internship
17	program in the preceding budget year. Bonus incentive funds may
18	be used to pay for costs of administering these programs and an
19	testing fees incurred by students in attaining credentials.

1	(h)	The department of education shall maintain records and
2	shall subm	ait a report of its findings and recommendations,
3	including	any proposed legislation, to the legislature no later
4	than twent	y days prior to the convening of each regular session
5	beginning	in 2020. The report shall include:
6	(1)	Types of credentials being earned and internships
7		being completed;
8	(2)	The schools offering these pathways and programs;
9	(3)	Aggregated demographics of student participants; and
10	(4)	The completion rate of enrolled students.
11	<u>(i)</u>	Qualified internship programs shall be exempted from
12	the Hawaii	public procurement code, chapter 103D, should they
13	meet the f	collowing criteria, as determined by the department of
14	business,	economic development, and tourism in partnership with
15	the depart	ment of education and the University of Hawaii.
16	Exempted q	qualified internship programs shall:
17	(1)	Be aligned with a post-secondary education or
18		employment opportunity;
19	(2)	Value the student's work equivalent to minimum wage;

T	(3)	Employ a sufficient number of internship case managers
2		to monitor student participation in the internship;
3	(4)	Provide students with pre-internship training or
4		coursework that is designed to prepare the students
5		for the internship; and
6	(5)	Implement adequate safety and supervisory safeguards
7		for the students participating in the internship."
8	SECT	ION 3. Section 103D-102, Hawaii Revised Statutes, is
. 9	amended by	y amending subsection (b) to read as follows:
10	"(b)	Notwithstanding subsection (a), this chapter shall
11	not apply	to contracts by governmental bodies:
12	(1)	Solicited or entered into before July 1, 1994, unless
13		the parties agree to its application to a contract
14		solicited or entered into prior to July 1, 1994;
15	(2)	To disburse funds, irrespective of their source:
16		(A) For grants as defined in section 42F-101, made by
17		the State in accordance with standards provided
18		by law as required by article VII, section 4, of
19		the state constitution; or by the counties
20		pursuant to their respective charters or
21		ordinances;

2		officers and employees for salaries, fringe
3		benefits, professional fees, or reimbursements;
4	(C)	To satisfy obligations that the State is required
5		to pay by law, including paying fees, permanent

7		refunds, and returning funds held by the State as
8		trustee, custodian, or bailee;
9	(D)	For entitlement programs, including public
10		assistance, unemployment, and workers'
11		compensation programs, established by state or
12		federal law;
13	(E)	For dues and fees of organizations of which the
14		State or its officers and employees are members,
15		including the National Association of Governors,
16		the National Association of State and County
17		Governments, and the Multi-State Tax Commission;
18	(F)	For deposit, investment, or safekeeping,
19		including expenses related to their deposit,
20		investment, or safekeeping;
21	(a)	To governmental hodies of the State:

T		(H) As loans, under loan programs administered by a
2		governmental body; and
3		(I) For contracts awarded in accordance with chapter
4		103F;
5	(3)	To procure goods, services, or construction from a
6		governmental body other than the University of Hawaii
7		bookstores, from the federal government, or from
8		another state or its political subdivision;
9	(4)	To procure the following goods or services which are
10		available from multiple sources but for which
11		procurement by competitive means is either not
12		practicable or not advantageous to the State:
13		(A) Services of expert witnesses for potential and
14		actual litigation of legal matters involving the
15		State, its agencies, and its officers and
16		employees, including administrative quasi-
17		judicial proceedings;
18		(B) Works of art for museum or public display;
19		(C) Research and reference materials including books,
20		maps, periodicals, and pamphlets, which are

1		published in print, video, audio, magnetic, or
2		electronic form;
3	(D)	Meats and foodstuffs for the Kalaupapa
4		settlement;
5	(E)	Opponents for athletic contests;
6	(F)	Utility services whose rates or prices are fixed
7		by regulatory processes or agencies;
8	(G)	Performances, including entertainment, speeches,
9		and cultural and artistic presentations;
10	(H)	Goods and services for commercial resale by the
11		State;
12	(I)	Services of printers, rating agencies, support
13		facilities, fiscal and paying agents, and
14		registrars for the issuance and sale of the
15		State's or counties' bonds;
16	(J)	Services of attorneys employed or retained to
17		advise, represent, or provide any other legal
18		service to the State or any of its agencies, on
19		matters arising under laws of another state or
20		foreign country, or in an action brought in
21		another state, federal, or foreign jurisdiction,

1			when substantially all legal services are
2			expected to be performed outside this State;
3		(K)	Financing agreements under chapter 37D; [and]
4		(上)	Any other goods or services which the policy
5			board determines by rules or the chief
6			procurement officer determines in writing is
7			available from multiple sources but for which
8			procurement by competitive means is either not
9			practicable or not advantageous to the State; and
10		(M)	Qualified internship programs as defined in
11			chapter 201- ; and
12	(5)	Whic	h are specific procurements expressly exempt from
13		any	or all of the requirements of this chapter by:
14		(A)	References in state or federal law to provisions
15			of this chapter or a section of this chapter, or
16			references to a particular requirement of this
17			chapter; and
18		(B)	Trade agreements, including the Uruguay Round
19			General Agreement on Tariffs and Trade (GATT)
20			which require certain non-construction and non-
21			software development procurements by the

1	comptroller to be conducted in accordance with
2	its terms."
3	SECTION 4. There is appropriated out of the general
4	revenues of the State of Hawaii the sum of \$500,000 or so much
5	thereof as may be necessary for fiscal year 2019-2020 and the
6	same sum or so much thereof as may be necessary for fiscal year
7	2020-2021 for the department of business, economic development,
8	and tourism to develop regional economic plans pursuant to
9	section 2 of this Act. The appropriation shall be divided
10	between \$300,000 for administrative costs and \$200,000 for
11	school incentive bonuses pursuant to section 2 of this Act.
12	The sums appropriated shall be expended by the department
13	of business, economic development, and tourism for the purposes
14	of this Act.
15	SECTION 5. Statutory material to be repealed is bracketed
16	and stricken. New statutory material is underscored.
17	SECTION 6. This Act shall take effect on July 1, 2019.
