## A BILL FOR AN ACT

RELATING TO ENVIRONMENTAL PROTECTION.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that polystyrene foam has 2 significant negative impacts on the environment. Due to its 3 lightweight nature and its ability to break down into smaller 4 fragments that persist for decades, polystyrene foam contributes 5 to the potential death of marine animals and avian populations 6 through ingestion. The legislature therefore believes that to 7 protect the State's unique environment and the health and 8 welfare of its marine and avian life, the use of polystyrene 9 foam containers for sale or service of prepared food within the 10 State should be prohibited.

11 The purpose of this Act is to promote public health, reduce 12 litter, and limit the entry of harmful materials into the 13 environment by prohibiting the sale of polystyrene foam food 14 service containers and the sale or service of prepared food 15 using polystyrene foam containers statewide. The legislature 16 anticipates that this Act will have the effect of encouraging

2	containers made from recyclable and compostable materials.
3	SECTION 2. The Hawaii Revised Statutes is amended by
4	adding a new chapter to title 19 to be appropriately designated
5	and to read as follows:
6	"CHAPTER
7	POLYSTYRENE FOAM CONTAINERS
8	<b>§ -1 Definitions.</b> As used in this chapter:
9	"Polystyrene" means a thermoplastic petrochemical material
10	utilizing a styrene monomer, including all polystyrene, meaning
11	any styrene or vinyl chloride polymer that is blown into a foam-
12	like material. Polystyrene includes materials created from
13	techniques including the fusion of polymer spheres (expandable
14	bead polystyrene), injection molding, foam molding, and
15	extrusion-blow molding (extruded foam polystyrene).
16	"Polystyrene foam container" means a container that is made
17	using polystyrene.
18	"Prepared food" means food or beverages that are prepared
19	to be consumed on or off the premises of a restaurant or food
20	establishment.
