BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 291-21.5, Hawaii Revised Statutes, is 1 2 amended by amending subsection (d) to read as follows: 3 "(d) This section shall not apply to: Rearview mirrors; 4 (1) 5 (2) Adjustable nontransparent sun visors [which] that are mounted forward of the side windows and are not 6 7 attached to the glazing material; Signs, stickers, or other materials [which] that are 8 9 displayed in a seven-inch square in the lower corner 10 of the windshield farthest removed from the driver or signs, stickers, or other materials [which] that are 11 12 displayed in a five-inch square in the lower corner of 13 the windshield nearest the driver; 14 (4)Rear trunk lid handle or hinges; Window wipers and window wiper motors; 15 (5)

Transparent sun screening film materials [which] that

are installed, affixed, or applied along the top edge

Motor Vehicles; Sun Screening Devices

Description:

Repeals provision requiring light transmittance of no less than thirty-five per cent on side and rear windows of certain vehicles using sun screening devices and glazing material. Expands exemption from regulation of sun screening side windows and rear windows of certain motor vehicles, including passenger vehicles, provided that the vehicles are equipped with rearview mirrors.
