#### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1	SECT	ION 1. Chapter 321, Hawaii Revised Statutes, is

5	departmen	t may establish reasonable fees to be collected from
6	individua	ls who are:
7	(1)	Transported by emergency ambulance services to any
8		medical facility; or
9	(2)	Provided emergency medical services by emergency
10		medical services personnel, including evaluations and
11		treatment, but are not subsequently transported to a
12		medical facility.
13	(b)	The department may adopt rules pursuant to chapter 91
14	necessary	for the purpose of this section, including the
15	establish	ment of reasonable fees."

14	2020-2021 to meet the collective bargaining requirements and			
15	recurring personnel costs for service providers contracted to			
16	provide pre-hospital emergency medical services necessary to			
17	maintain the current level of pre-hospital emergency medical			
18	services.			

19 The sum appropriated shall be expended by the department of20 health for the purposes of this Act.
