Description:

Requires medicaid and insurance coverage of ambulance services. Authorizes medicaid programs, and requires private insurers, to pay for community paramedicine services provided by emergency medical technicians or paramedics. Appropriates moneys for medicaid to cover community paramedicine services provided by emergency medical technicians or paramedics. Appropriates funds for ambulance services covered by medicaid.
