A BILL FOR AN ACT

RELATING TO THE CONTRACTORS LICENSE BOARD.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 1 | SECTION 1. Section 444-1, Hawaii Revised Statutes, is |

| 13 | SECTION 2. Section 444-8, Hawaii Revised Statutes, is |

| 16 | contractors license board may adopt rules and regulations |
| 17 | necessary to effect the classification of contractors in a |

1 manner consistent with established usage and procedure as found 2 in the construction business, and may limit the field and scope 3 of the operations of a licensed contractor to those in which the 4 contractor is classified and qualified to engage, as defined in 5 section 444-7.

6 (b) A licensee may make application for classification and 7 be classified in more than one classification if the licensee 8 meets the qualifications prescribed by the board for such 9 additional classification or classifications. For qualifying or 10 classifying in additional classifications, the licensee shall 11 pay the appropriate application fee but shall not be required to 12 pay any additional license fee.

(c) This section shall not prohibit a specialty
contractor, acting as a subcontractor, from taking and executing
a contract involving the use of two or more crafts or trades, if
the performance of the work in the crafts or trades, other than
in which the specialty contractor is licensed, is incidental and
supplemental to the performance of work in the craft for which
the specialty contractor is licensed.

20 (d) Notwithstanding subsection (c), incidental and
21 supplemental work shall be prohibited on any project requiring

Report Title:

Contractors; Subcontractors; Specialty Contractors; Incidental and Supplemental Work

Description:

Clarifies that a specialty contractor, acting as a subcontractor, is not prohibited from taking and executing a construction contract involving two or more crafts or trades if the performance of the work is incidental and supplemental. Prohibits incidental and supplemental work on any project requiring the seal or stamp of professional engineer licensed to perform structural engineering. Specifies certain specialty contractor subclassifications that shall not be considered incidental and supplemental work.
