### A BILL FOR AN ACT

RELATING TO MINIMUM WAGE.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 46, Hawaii Revised Statutes, is amended 2 by adding a new section to be appropriately designated and to 3 read as follows: Minimum wage. Each county may adopt ordinances 4 "§46establishing a minimum wage rate that is greater than or equal 5 6 to the minimum wage provided in section 387-2." SECTION 2. Section 387-2, Hawaii Revised Statutes, is 7 amended by amending subsection (a) to read as follows: 8 9 "(a) Except as provided in section 387-9 and this section, 10 every employer shall pay to each employee employed by the employer, wages at the rate of not less than: 11 12 (1)[\$6.25 per hour beginning January 1, 2003; \$6.75 per hour beginning January 1, 2006; 13 (2)14 (3) \$7.25 per hour beginning January 1, 2007; (4) \$7.75 per hour beginning January 1, 2015; 15 (5) \$8.50 per hour beginning January 1, 2016; 16 (6) \$9.25 per hour beginning January 1, 2017; and 17
